### 6. TOPIC OF DISCUSSION

6.1. General Legal Department Updates (Presenter – Linda Epstein, General Counsel)

Ms. Epstein shared the following Legal Department updates with the committee:

- Budget
  - Review of the outside legal costs incurred and overall budget status for the period of July 2022 through April 2023.
    - Total budget spend \$3,646,945.36
    - Board approved budget \$10,545,000
- Fair Market Value (FMV) (Presenter Gerald Del Amo, Deputy General Counsel)

Mr. Jerry Del Amo, Deputy General Counsel, provided the following FMV budget update:

- Total FMV spend \$488,184.80
- Board approved FMV budget \$950K

Discussion ensued regarding FMV vendors and spend. Commissioner Williams requested that a Request for Proposal (RFP) be issued for upcoming FMV engagements.

Ms. Epstein further shared that the three (3) following outside law firms had been added to the organization's panel:

- Bonnie Miskel of Dunay, Miskel and Backman LLP specializing in land use and zoning law in municipalities throughout Broward County particularly in Weston area;
- Waller Lansden due to name change as Holland & Knight was acquired; and
- Christopher Kenny, Esq. of King & Spalding LLP specializing in compliance advice to hospitals.
