EASEMENT FOR INGRESS/EGRESS

Grantors do hereby grant, bargain, sell, convey and warrant to Grantees an easement for purposes of ingress and egress to Grantee property. Said easement shall run across Grantor Property and includes all rights typically associated with ingress and egress easements to be extended to include all tenants, guests, employees and general members of the public. Grantors are prohibited from constructing, placing or permitting any obstructions within the easement area that interfere with this easement for ingress and egress.
