The Pension and Investment Committee reviewed the August 30, 2023 Amended and Restated Investment Policy Statement of the North Broward Hospital District Employees' Pension Plan (Employees' Pension Plan Investment Policy ") and recommends that the Board of Commissioners of the North Broward Hospital District approve the Employees' Pension Plan Investment Policy amendments, to include revised language, subject to final Board approval.

6.4. SSgA S&P Index Fund ex Tobacco (Presenter – Alisa Bert, VP, Interim Chief Financial Officer)

**MOTION** It was *moved* by Commissioner Berry, *seconded* by Commissioner Tanner, that:

The Pension and Investment Committee recommends that the Board of Commissioners of the North Broward Hospital District retain the SSgA S&P 500 Index Fund excluding Tobacco ("ex Tobacco") based on pecuniary factors.
