

Dear IMLCC Commissioners -

I want to provide you with an update on the API development project.

The IMLCC IT team, under the leadership of Matt Robison, has taken an "all hands on deck" approach to the API development project. The result of this approach is that all 4 API projects will be completed and available for member board development by January 1, 2025. Please see the technical explanation from Matt below to be shared with your board's IT team. Please contact Matt directly, if you or your IT team have questions.

The IMLCC API 2.0 Release with Power Apps Integration will automate the current manual data entry and manipulation process currently housed in the Dynamics CRM. Version 2.0 of the IMLCC API will build upon the ability to automatically list, view license details, and approve or deny renewal licenses. This version of the IMLCC API software will add the other two license workflows Initial SOS and Additional SOS. State Boards will be able to begin requesting access to the IMLCC API Version 2.0 as of November 1st, 2024. Like the current IMLCC API 1.1.3 Renewal software Version 2.0 (All Licenses Release} will be split into two parts. The Power Apps notification system, which will send out email notifications that are in the "MB Review" stage to the State Board email on record in the CRM. The Second part is the API IMLCC API itself which will include three functions (End Points) for the Software developed by the State Board to Interact with the IMLCC API. In addition, an additional function will be available to test API connectivity to the Dataverse.

Once we have built Version 2.0 of the IMLCC API we will be adding additional End Points which will allow State Boards to automatically interact with SPL Letters of Qualification. This will include the rest of the workflows currently in the Dynamics CRM. Version 2.1 of the IMLCC API (LOQ release) will target the Initial Application, LOQ Re-Apply, and Redesignation workflows. State Boards will be able to begin requesting access to these new End Points as of December 1st, 2024. As in the All-Licenses Release (version 2.0) this release will be split into two parts consisting of the Power Pages notification system, which will send out email notifications that are in the "SPL Approval" stage to the State Board email on record in the CRM. This release will create three additional End Points. State Boards will be able to list, and view application details of the SPL LOQ applications. In addition, Version 2.1 will give the State Board the ability to act on the LOQ Application to make it Eligible or Ineligible for the State of Principal Licensure. This feature will only be available for State Boards that currently act as an SPL.

After Version 2.1 is completed, we will be adding the ability to Interface with the Physician's Profile automatically with integration to the IMLCC API version 2.2. Currently State Boards can create, update, and Physician Records in the Dynamics CRM. Version

2.2 of the IMLCC API (Contact release) will give the ability to State Boards to act on Physician Contact Records without manually interacting with the Dynamics CRM. State Boards will be able to begin requesting access to the new End Points as of January 1st, 2026. This release will create three more additional End Points. State Boards will be able to list and view physician contact details which use the State as an SPL or have a license with the state.
