 - a. Futures Lab has been designed specifically to complement and extend existing offerings at comprehensive and small, alternative secondary schools in the Poudre School District and to make those options accessible to all students. Lower level (1 & 2) courses are offered selectively at some of our comprehensive high schools, but CTE offerings at our small and alternative sites are limited or non-existent. Futures Lab is the only facility in the district where students can take upper-level courses that result in program concentrator status.

Linked to this application, you will find promotional flyers for the five CTE approved pathways for the 21-22 school year. We are launching 2 additional CTE pathways for the 22-23 school year to include Manufacturing and Natural Resources

- <u>Aviation</u> Futures Lab is the only site in PSD where this program is available.
- <u>Culinary/ProStart</u> Level 1 and, in some cases, Level 2 classes are offered at most of our comprehensive high schools. Futures Lab is the only location in the district that offers the ProStart program.
- <u>Networking & Cybersecurity</u> The Level 1 course is offered at our comprehensive high schools and students can complete the sequence through Futures Lab. No other PSD schools offer the Networking pathway. In this pathway, Futures Lab also offers the Level 1 course so that the full sequence is accessible to students at small, alternative high schools who otherwise do not have the resources to support offering it.
- <u>Multimedia/Audio Production</u> One comprehensive high school site offers the Level 1 and 2 classes in Graphic Design; those students can complete the program at Futures Lab. Futures Lab is the only place that students at all other schools can access the full Graphic Design program. The Audio Production and Management Pathway is only offered at Futures Lab.
- <u>Construction Design Build</u>- Futures Lab is currently offering level 2 and 3 courses that aren't offered at sites and plan to focus on HVAC during the 22-23 school year. The HVAC pathway is not offered at any other schools.

To better support Colorado students who are English language learners, the State Board of Education adopted new rules in June 2018 requiring teachers with elementary, English language arts, math, science and social studies endorsements to complete Culturally and Linguistically Diverse education training or English Learner Professional Development.

While a requirement for holders of teacher licenses with these five endorsements only, it is optional for all other educators. As such, one of three designations has been added to your certificate:

- "No" indicates that you have not yet met the requirement and will need to do so (information about the timeframe follows).
- "Yes" indicates that you have met the requirement and do not need to do anything additional with regard to it.
- "Optional" indicates that, based on the license and endorsement(s) you presently hold, you do not need to fulfill this requirement but have the option to do so. It is important to note that should you add one of the five endorsements to your license at a later date, the designation will change to "No" and you will need to meet the requirement at the time of your next renewal.

Teachers holding a professional five-year license endorsed in elementary, English language arts, math, science or social studies endorsement must meet the new licensing requirement as follows:

- If the effective date of your professional license is 9.1.2018 or later, you will need to meet this requirement within your present <u>five-year</u> license renewal period. (For example, if your professional license was issued on 9.1.2018, you will need to provide evidence of meeting this requirement when you submit a renewal application in 2023.)
- If the effective date of your current professional license is *prior to* 9.1.2018, you may renew this license one time before needing to show evidence that you have fulfilled the requirement. (For example, if your license was issued on 8.31.2018, you would not have to submit this documentation until you renew in 2028.)
- If you do not fulfill this requirement accordingly, your license will not be renewed.
- You need only to satisfy this requirement once during the course of your Colorado professional educator licensure history.
