IX. Discussion and Possible Action State Preschool Program

The Board discussed realities and options for the state preschool program. Kristin Hills (MCOE State Preschool director) has recommended to close for the remainder of the year. This could mean a \$17,000 loss of reimbursement for May and June, and after putting a hold on our license until we can reopen in the fall after recruiting quality staff for the program. current enrolled families could be transferred to available preschools in Ukiah, with an easy paperwork transition (though not for transportation). K Hills is not in favor of us trying to limp along for the rest of the year with subs as it will not be a quality program and may compromise continuity for students. The CDE does not need to be involved since there was no "type A" findings from licensing. Students can enroll for next year if they will be turning 3 by Dec. 1 2024. Amy shared a copy of the letter that will go out to preschool families. We will also consider if attending a tribal council meeting to open lines of communication about the preschool, pending advice from tribal council. with no other options President Frost recommended closing the program, notice families, and hold a restorative circle with families, and acknowledge where we stand with our preschool implementation with our community partner (the Hopland Band of Pomo Indians).
