SUBJECT: Request Board Approval for capital funding for the demolition of the Copper Kettle

site and other acquired real estate adjacent to it, and for the demolition of 3 residences recently acquired along SE 3^{rd} Ave to allow temporary staff parking.

BACKGROUND

Broward Health has acquired the following properties over the past few years. The Copper Kettle Site is composed of the following addresses: 1611-1619 S Andrews Ave; 1623 S Andrews Ave; 9 SW 17th St; and 17 SW 17th St. The ISC North Parcels are composed of the following address: 1508 SE 3rd Ave; 1520 SE 3rd Ave; and 1524 SE 3rd Ave. Broward Health would like to demolish these houses and provide compacted gravel over the sub-grade for site prep for interim temporary parking and future site development.

ACTION/PROJECT DESCRIPTION

Board approval for capital funding of \$1,305,197.00 for the demolition of the Copper Kettle and other acquired real estate adjacent to it and the demolition of 3 residences recently acquired along SE 3rd Avenue.
