TOPIC: Colorado Community College System Information Technology Spending Authority Request for Oracle Exadata Contract

RELATIONSHIP TO THE STRATEGIC PLAN:

Redefine our value proposition through accessibility, affordability, quality, accountability, resource development and operational excellence.

EXPLANATION:

Oracle databases are the foundation of CCCS's systems of record. All student, employee, and financial data ultimately reside in one or more Oracle databases managed by CCCS System IT. System IT purchases software support and maintenance from Oracle on an annual basis. The support and maintenance cost in FY25 is projected to be \$537,945 and increases by 6% every year.

System IT proposes to modernize our database architecture by adopting Oracle's Exadata Cloud at Customer database system. Exadata Cloud at Customer provides the fiscal flexibility of a usage-based cloud pricing model with the security and simplicity of retaining the databases in our own IT facilities. Exadata Cloud at Customer also enables CCCS to take advantage of additional database functionality such as a more rigorous data encryption that is not currently part of our Oracle license.

System IT projects that our Oracle usage will be flat or decline over the next five years, due largely to the adoption of cloud-based software as a service (SaaS). This provides an opportunity to right-size our Oracle license and lock in prices over a five-year period. By right sizing the Oracle license and avoiding the 6% annual maintenance cost increase, System IT projects savings of over \$400,000 over the next five years.
