What is the purpose of this contract and why is it needed? SSH Accreditation is a peer-reviewed, customized evaluation of your healthcare simulation program. This accreditation examines simulation program's processes and outcomes in assessment, research, teaching/education, and systems integration. To remain accredited, the simulation center must be a SSH member. The simulation center director and or designated staff must have access to SSH to submit annual reports, accreditation documents and so forth.

What procurement process or bid waiver was used and why? Small purchase for Category One (\$0.00 - \$10,000) per College Procedure A6Hx2-6.34 was used, where there are no formal or informal competitive requirements for goods and services acquired by the College at this dollar threshold. Membership dues, per the Florida Statute 119.01(3) requires that all financial, business and membership records held by the organization in relation to the individual(s) or organization(s) for whom a purchase order is being issued are to be considered public records and shall be subject to the provisions of Florida Statute 119.07.

Is this a budgeted expenditure from the budget established at the last June Board of Trustees meeting? Yes.

What fund, cost center and line item(s) were used? FD100; CC0334; GLC- 64502:Inst. Memberships and Sponsorships.

Has Broward College used this vendor before for these products or services? Yes.

Was the product or service acceptable in the past? Yes.

Was there a return on investment anticipated when entering this contract? The SSH Membership is where Dr. Lilia Chavarria now serves as Vice Chair on the SSH Patient Safety & Simulation Collaborative Affinity Group. Also Dr. Chavarria is on the Development Task Committee with Barbara Genader.

We exceeded expectations due to Dr. Lilia Chavarria traveling to the IMSH Conference to present on behalf of the Health Sciences Simulation Center, which put out Broward Colleges successes worldwide.
