Recommendation that the Broward College District Board of Trustees authorize a standard agreement (purchase order) with Cheyenne Kellar to provide choreography and master class services for the Spring 2025 dance program. Fiscal Impact: \$1,075.00.

What is the purpose of this contract and why is it needed? This contract with choreographer Cheyenne Kellar will provide students access to a professionally choreographed dance piece for the Spring 2025 Dance Concert. Work provided includes 50-75 hours of preparation with student dancers, master classes for all dance students and the creation of new dance pieces over the course of one term for our student performers' use.

What procurement process or bid waiver was used and why? Small purchase for Category One (\$0.00 - \$10,000) per College Procedure A6Hx2-6.34 was used, where there are no formal or informal competitive requirements for goods and services acquired by the College at this dollar threshold. One quote was obtained by the requesting department to identify the best value for the required commodity or service.

This expenditure will make use of the budget established at the June 2024 Board of Trustees meeting.

What fund, cost center and line item(s) were used? This is a Fund 100, CC0532 Dance expenditure, GLC 64500.
