## **EXECUTIVE SUMMARY**

Pursuant to Broward College Policy 6Hx2-1.14 and Procedure A6Hx2-1.14, Dr. Donald Astrab exercised the authority delegated by the Board to execute the non-standard contract with Omnigo Software LLC for software licensing and support for the Safety and Security departments report management system by using the bid waiver information technology resources. Fiscal Impact: Estimate \$140,557.31 (over four years) (Cumulative \$188,272.31)

What is the purpose of this contract and why is it needed? Omnigo Software LLC is the vendor supplier for the ReportExec software suite, Broward College's security management platform used for all campus safety dispatching and report writing to include but not limited to workman's comp, criminal activity, and lost and found property reports. ReportExec also serves as BC's single point of data collection for all Campus Safety activities which produces statistics used to maintain compliance with the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act.

What procurement process or bid waiver was used and why? FL DOE 6A-14.0734(2)(g), Information technology resources defined as all forms of technology used to create, process, store, transmit, exchange and used information in various forms of voice, video and data, and shall also include the personnel costs and contracts that provide direct information technology support consistent with each individual college's information technology plan.

Is this a budgeted expenditure from the budget established at the last June Board of Trustees meeting? Yes.

What fund, cost center and line item(s) were used? FD100 CC0246 65700: Data Software - Non-Capitalized.

Has Broward College used this vendor before for these products or services? Yes.

Was the product or service acceptable in the past? Yes.

Was there a return on investment anticipated when entering this contract? Yes. Improved record keeping and compliance provides greater efficiencies in providing Safety and Security services to the Campus Community.

Was that return on investment not met, met, or exceeded and how? ROI was met through creation and maintenance of a database generated from incoming calls for service and officer reports. This provided accountability tools and documentation to generate statistics for federally required crime reporting.

Does this directly or indirectly feed one of the Social Enterprise tactics and how? This contract supports the college's strategic objectives as part of the overall effort to ensure the safety and security of students, faculty and students and improves the College's ability to track and response to incidents on campus.
