Board of Visitors

What Authorities Govern the Handbook?

The Board of Visitors (BOV) is the ultimate institutional authority under the *Code of Virginia*. Per the *Faculty Handbook*, p. 8, "Nothing in this document shall affect the powers of the Board of Visitors as provided by law."

Per the **BOV Bylaws**, the BOV approves major policy and organization changes per the **president's** recommendation – or delegates such authority to the president.

As approved by the BOV, the *Faculty Handbook* specifies roles, delegations, and processes related to academic matters – including the formal advisory role of **Faculty Assembly** and the **Personnel Policy Committee** with respect to amendments.

Why Revise?

- 1. The legal landscape has changed significantly since 2008
- 2. Multiple academic entities are considering reorganization and should have due recognition in their new forms: A&S, CDAS, etc.
- Governance reviews are expected for accreditation on a 10-year cycle (due 2026)

Principles for Revision

- 1. Assume positive intent
- 2. Respect the time of all involved
- 3. Work in a transparent way
 - Set clear deadlines and deliverables
 - Give due regard to established roles and authorities
 - Consult multiple perspectives and constituencies
 - Show and tell process

Faculty Handbook Committee

President's Charge to the Committee: lead a transparent process for updating the *Faculty Handbook*, consistent with the Board's September 2023 charge. Identify goals for revision from key constituencies, establish and publish a scope of work, then seek approval for changes and craft language per those approvals. Complete work by Fall 2024.
