- **Committee Reports**

- **Property:** Director Dallas advised that the damage from a leak in the upstairs bathroom was covered by insurance minus \$1000 deductible. The claim included replacement vinyl base for upstairs bathroom and front office, replace flooring in the second floor bathroom, and the Supreme Cleaners clean up invoices. The front office will be re-painted and with vinyl base replacement, it would be prudent to replace the 25-year old carpeting in the two main offices. The proposal for carpet tiles was reviewed and discussed. Josh Tucker made a motion, seconded by Pat Hilliker, to approve the proposal for materials and labor from Brothers Flooring in the amount of \$3,879.50.

- **Executive:**

Chairman Sibley advised the State has denied the ETSB's second request to change our 911 System Service Provider. The denial email indicated a change in service provider other than the one contracted with prior to July 2021 when the Statewide NG911 contract with AT&T was signed would not be approved. The denial further indicated the legislature intended to allow systems to utilize their current infrastructure so long as it meets the standards adopted as it existed upon signing the Statewide NG911 contract. Director Dallas responded

indicating concern that Lee County ETSB has with Lumen's current level of service, specifically relating to the 30 plus hour outage that took place March 6th – March 7th, 2022 along with the longevity of previous outages over the past few years and requested a timeline that Lee County will be put on the list to transition to the AT&T ESINet.

A brief synopsis was provided regarding the 911 outage on March 6-7. During the wind storm, there was intermittent power outages which caused the transfer switch at the Lumen Central Office to fluctuation and to not transfer to generator but remain on UPS until the load could no longer be carried and power died. Timeline of events was provided once power was restored to included rebuilding and restoring the Central office switch and 911 trunking. The entire Dixon exchange (284, 285, 288 was out of service). Further discussion and explanation took place. Although Director Dallas was notified of the outage while on vacation, the dispatchers on duty and IT Administrator McBride stepped up, took control of the outage and implemented the contingency plan, with modifications, flawlessly.

The agreement for 911 dispatch services was signed in 2013. Since the inception of the agreement, there have been numerous changes to include scheduling which has the potential to involve union issues and it may be a good time to review the contract to re-evaluate the ETSB and County responsibilities. Considerable discussion took place.

- **Education Committee:**

Director Dallas and Jes Knipple visited Washington School on March 15th for Public Education with the Pre-K classes. TC Week is April 10th – April 16th. Scheduling in April may be an issue to get out to the other schools.
