



EXECUTIVE SUMMARY

Pursuant to Broward College Policy 6Hx2-1.14 and Procedure A6Hx2-1.14, Broward College exercised the authority delegated by the Board to issue a standard agreement (purchase order) with Vintage King Audio for the renewal of software for the music technology program. Fiscal Impact: \$4,669.00 (cumulative \$61,200.27)

What is the purpose of this contract and why is it needed? This contract is for software renewals used in the AS in Music Technology and Music Production programs. This software is critical to the operation of the music technology labs and is a primary need for students in the program. The software must be installed by the beginning of term AY 2024-25.

What procurement process or bid waiver was used and why? Small purchase for Category One (\$0.00-\$10,000) per College Procedure A6Hx2-6.34 was used, where there are no formal or informal competitive requirements for goods and services provided by the College at this dollar threshold. One quote was obtained by the requesting department to identify the best value for the required commodity or service. No bid waiver was used.

Is this a budgeted expenditure from the budget established at the last June Board of Trustees meeting? Yes, this expenditure will make use of the budget established at the upcoming June Board of Trustees meeting.

What fund, cost center and line item(s) were used? FD100, CC0531; 62500: Repairs & Maintenance.

Was there a return on investment anticipated when entering this contract? The return on investment is student retention and completion as this contract ensures that students have access to train using the technology and equipment used in the field.
