**APPROVAL OF REVISED FY 2022 - 2023 TUITION AND FEES**

Beginning with the spring semester for FY 2023, it is recommended that a new Program Fee of \$142 per credit hour be established for the Global Student Success Program.

An updated FY 2023 tuition and fee summary sheet is attached. No changes are presented for the tuition rates or mandatory fees previously approved by the Board of Visitors in May 2022.

Richard Bland College's ("the College") goal remains to deliver high quality educational programming, high-value university pathways and innovative education models to students while minimizing student cost.

**WHEREAS**, that the William & Mary Board of Visitors, upon the recommendation of the President, recognizes the unforeseen financial circumstances impacting our students and their families, may require the College to adjust or reconsider non-mandatory fees and charges; and

**WHEREAS**, having no increase for FY 2023 tuition and mandatory E&G fees, will result in no significant increase for the College's returning or incoming students;

**THEREFORE, BE RESOLVED**, that the President and the Chief Business Officer are granted the authority and the discretion to determine whether non-mandatory fees will be waived or applied for courses, programs, and activities; and

**BE IT FURTHER RESOLVED**, that upon recommendation of the President, the William & Mary Board of Visitors approves the revised FY 2022- 2023 Tuition and Fee Summary Richard Bland College as outlined on pages 2 and 3.
