# **Purpose and Issues to be Considered:**

Does the narrative provided within the attached documents adequately represent the business of the Foundation during the stated reporting period?

### **Background:**

Each year, the UCF Foundation Audit Committee reviews the IRS Forms 990 and 990-T, and Florida Department of Revenue form F-1120 and all related disclosure forms that are prepared by independent accounting firm, CliftonLarsonAllen (CLA), in collaboration with the UCF Foundation accounting team. Form 990 is a public information document for not-for-profit organizations that are exempt from taxation. Form 990-T reports any taxable income earned by unrelated business activity (UBI) and is subject to taxation. Form F-1120 is the Florida Corporate Income tax return. The Audit Committee recommended approval of IRS Forms 990 and 990-T and the Florida Department form F-1120 on April 25, 2023.

The UCF Foundation's total federal tax liability for the year ended June 30, 2022, was \$19,979.

### **Recommended Action:**

Approve IRS Forms 990 and 990-T and Florida Department of Revenue form F-1120 for the fiscal year ended June 30, 2022, as presented.

#### **Alternatives to Decision:**

Decline to approve and request revisions for future consideration.

#### **Fiscal Impact and Source of Funding:**

The fiscal year 2021-2022 total federal tax liability for unrelated business income was \$19,979. The fiscal year 2021-2022 total State of Florida tax liability was \$386.
