10.1. CEO Update (Presenter - Shane Strum, President, Chief Executive Officer)

Mr. Strum presented his full monthly report, highlighting the five pillars (Quality, Service, People, Growth, and Finance) of the organization and the progress at each of the facilities.

The following videos were shared:

Video featured Baby Alanie Lettsome, born at just 23 weeks and weighing a little over one pound; classified as a micro preemie.

It was noted that Alanie's mother sought care at the hospital's flagship location due to cervical incompetence, putting her at high risk of a premature delivery.

Although Alanie required extensive care in his early days and was placed on a ventilator, he managed to avoid common complications associated with premature births, such as brain bleeding and intestinal issues.

After spending 5 months under the dedicated care and monitoring of Broward Health Medical Center's multidisciplinary team, and at Broward Health, Baby Alanie, weighing over 9 pounds, and his parents were released to go home.

In addition, Mr. Strum introduced new leader, Mr. Dane Ficco, Chief Executive Officer of Broward Health Physician Group and Broward HealthPoint. Mr. Ficco provided a high-level overview of his career.

Mr. Strum shared the success of the 10th Annual Broward Health Ball held on May 20, 2023, which raised the most money to date, raising over \$1M. It was noted that the event benefits programs to enhance patient care and services at Broward Health.
