AHCA Annual Report:

Fall with Hip Fracture - 66-year-old female was found, by primary RN, on the floor next to her bed. The patient stated that she went to the restroom and while attempting to return to the bed, her legs gave out and she fell to the floor. Patient was a high-risk for falls, no bed alarm on. There was a delay in obtaining imaging which eventual showed a nondisplaced greater trochanteric fracture. No surgery required. Fall with Subdural Hematoma - 57-year-old male was found by RN standing outside the bathroom with a bloody laceration noted to the patient's forehead. Per RN report, the patient stated that he did not remember what happened or how he got to the bathroom. Patient had a seizure 2 hours prior to fall and also had a seizure in CT during brain imaging. Imaging showed bilateral subdural hematomas. Patient remained at neurological baseline and no surgery was required. Seizure precautions were not documented, delay in response to bed alarm. Fall with Elbow Fracture - 75-year-old female fell while ambulating in hallway. Charge RN and secretary were at the nursing station when they heard a noise, described as a thump. The unit secretary and charge RN immediately responded to noise and found the patient laying on her left side with blood coming from a laceration to her left eyebrow. Sutures were required for laceration and left arm x-rays showed fracture involving the distal humerus. No bed alarm in place, no fall alert called.

Fall with Rib Fractures - 82-year-old patient found on the floor next to his bed when nursing responded to bed alarm. Patient complained of chest pain and eventually a chest x-ray was completed which confirmed fractures of the left 7th through 9th ribs. No surgery was required. Delay in acquiring imaging and notifying NOK.
