NOTICE OF INTENT TO ANNEX

IN THE MATTER OF THE PETITION
OF THE CITY OF PRINCEOTN
FOR ANNEXATION PURSUANT TO
MINNESOTA STATUTES SECTION 414.033, SUBDIVISION 3

WHEREAS, the area proposed for annexation described below is not presently with the corporate limits of any incorporated city; and

WHEREAS, the area proposed for annexation is 40 acres or less in size, is 60% or more bordered by land already within the corporate limits of the City of Princeton, as demonstrated on the attached exhibit; and

WHEREAS, the area proposed for annexation is not appropriate for annexation by ordinance pursuant to Minnesota Statutes 414.033, Subd.2(3); and

WHEREAS, the area proposed for annexation is outlined/highlighted on the attached map and is legally described as follows:

That part of the Southwest Quarter of the Southeast Quarter of the Southeast Quarter (SW ¼ of SE ¼ of SE 1.4 of Section Twenty-one (21), Township Thirty-six (36), Range Twenty-six (26), Mille Lacs County, Minnesota, lying South of the following described line:

Commencing at the Southwest corner of said Southwest Quarter of the Southeast quarter of the Southeast Quarter (SW ¼ of SE ¼ of SE ¼) of Section Twenty-one (21); thence North 01 degrees 21 minutes 12 seconds West, assumed basis of bearings, along the West line of said Southwest Quarter (SW ¼) a distance of 460.00 feet to the point of beginning of the line to be described; thence South 89 degrees 06 minutes 35 seconds East 250.00 feet; thence South 45 degrees 11 minutes 00 seconds East 604.96 feet to a point on the East line of said Southwest Quarter (SW ¼), distant 40.00 feet northerly from the Southeast corner thereof, and there terminating.

SUBJECT TO DRAINAGE AND UTILITIY EASEMENTS AS FOLLOWS:

A tract for easement being the East 10 feet of the West 43 feet of the following described land, hereinafter referred to as the Subject parcel:

That part of the Southwest Quarter of the Southeast Quarter of the Southeast Quarter (SW ¼ of SE ¼ of SE ¼) of Section Twenty-one (21), lying south of the following described line:

Commencing at the Southwest corner of said Southwest Quarter of the Southeast Quarter of the Southeast Quarter (SW ¼ of SE ¼ of SE ¼) of Section Twenty-one (21); thence North 01 degrees 21 minutes 12 seconds West, assumed basis of bearings, along the West line of said Southwest Quarter (SW ¼) a distance of 460.00 feet to the point of beginning of the line to be described; thence South 89 degrees 06 minutes 35 seconds East 250.00 feet; thence South

45 degrees 11 minutes 00 seconds East 604.96 feet to a point on the East line of said Southwest Quarter (SW $\frac{1}{4}$), distant 40.00 feet northerly from the Southeast corner thereof, and there terminating.

Together with a tract for easement being a part of said Subject Parcel, and being a 5-foot strip of land lying southerly and southwesterly of the following described line:

Commencing at the Southwest corner of said Southwest Quarter of the Southeast Quarter of the Southeast Quarter (SW ¼ of SE ¼ of SE ¼) of Section Twenty-one (21); thence North 01 degrees 21 minutes 12 seconds West, assumed basis of bearings, along the West line of said Southwest Quarter (SW ¼) a distance of 460.00 feet; thence South 89 degrees 06 minutes 35 seconds East a distance of 43.03 feet to the Northeast corner of the 10-foot strip first above-described, being the point of beginning of the line to be described; thence continuing South 89 degrees 06 minutes 35 seconds East 206.97 feet; thence South 45 degrees 11 minutes 00 seconds East 604.96 feet to a point on the East line of said Southwest Quarter (SW ¼), distant 40.00 feet northerly from the Southeast corner thereof, and there terminating.
