



EXECUTIVE SUMMARY

Recommendation that the Broward College District Board of Trustees authorize a standard agreement (purchase order) with FLORIDA COLLEGE SYSTEM ACTIVITIES ASSOCIATION (FCSAA) for membership renewal and dues for Broward College by utilizing the bid waiver exemption for single or sole source. Fiscal Impact: \$29,788.05

What is the purpose of this contract and why is it needed? Membership to the Florida College System Activities Association (FCSAA) provides the following benefits that are exclusive to members and are not available via any other organization or service.

- FCSAA provides a platform for our Student Government Associations as voices in our state legislature.
- Brain Bowl and Model United Nations, state competitions and educational programs help students to become strong in public speaking skills.
- In the Performing and Fine Arts, the Association hosts music symposiums, annual publication conventions, and theatrical adjudications.

What procurement process or bid waiver was used and why? Bid waiver exception pursuant to FLDOE 6A-14.0734(2) (e) and College Procedure A6Hx2-6.34 for Services or commodities available from a single or sole source.

Is this a budgeted expenditure from the budget established at the last June Board of Trustees meeting? Yes, we will utilize the Student Activity & Service Fees Fund 2 Budget.

What fund, cost center and line item(s) were used? FD201, CC0136, PG000174, BU301, GLC 64502.

Has Broward College used this vendor before for these products or services? Yes, Broward College has been participating for years in the Academic Divisions of Brain Bowl, Forensics, Model United Nations, Music, Publications, and Student Government.

Was the product or service acceptable in the past? Yes, this membership allows our students to participate in FCSAA activities such as conferences and competitions.

Was there a return on investment anticipated when entering this contract? We anticipate students will retain at higher rates as a result of involvement and develop a deeper sense of belonging at the College.

Was that return on investment not met, met, or exceeded and how? Co-curricular activities offerings have increased as a result of involvement in FCSAA.
