Recommendation that the Broward College District Board of Trustees authorize a standard agreement (purchase order) with Women in Aviation International for membership renewal corporate dues in the Aviation Program. Fiscal Impact: \$500.00

What is the purpose of this contract and why is it needed? Women in Aviation International Membership is important for the Aviation Dept. in maintaining networking connections, event opportunities, scholarship for students. Women in Aviation ". . . encourage(s), empower(s), and educate(s) all those whose interests, lives, and work involve aviation and aerospace regardless of race, ethnicity, gender identity, age, sexual orientation, physical or mental abilities, or point of view." What procurement process or bid waiver was used and why? Small purchase for Category One (\$0.00 - \$10,000) per College Procedure A6Hx2-6.34 was used, where there are no formal or informal competitive requirements for goods and services acquired by the College at this dollar threshold. Membership dues, per the Florida Statute 119.01(3) requires that all financial, business and membership records held by the organization in relation to the individual(s) or organization(s) for whom a purchase order is being issued are to be considered public records and shall be subject to the provisions of Florida Statute 119.07.

Is this a budgeted expenditure from the budget established at the last June Board of Trustees meeting? Yes.

What fund, cost center and line item(s) were used? CC0020, FD100, BU030, PG000086.

Has Broward College used this vendor before for these products or services? Yes.

Was the product or service acceptable in the past? Yes.

Was there a return on investment anticipated when entering this contract? No.
