Recommendation that the Broward College District Board of Trustees authorize a standard agreement (purchase order) with the Commission on Accreditation of Allied Health Education Programs (CAAHEP) for Annual CAAHEP 2024-2025 Accredited Program fee renewal for the Diagnostic Medical Sonography and EMS/Paramedic Program. Fiscal Impact: \$1,200.00

What is the purpose of this contract and why is it needed? The annual accreditation fee is required by The Commission on Accreditation of Allied Health Education (CAAHEP) for ongoing accreditation. Accrediting bodies monitor institutions regularly to ensure continued compliance with standards. The CAAHEP fees support their ongoing monitoring activities, including periodic reports, data analysis, and follow-up evaluations. CAAHEP accreditation ensures that the Diagnostic Medical Sonography and EMT and paramedic programs meet specific educational standards and provide high-quality training to future professionals.

What procurement process or bid waiver was used and why? Small purchase for Category One (\$0.00 - \$10,000) per College Procedure A6Hx2-6.34 was used, where there are no formal or informal competitive requirements for goods and services acquired by the College at this dollar threshold.
