Board Briefing Summary

• Enrollment is looking great. Headcount is currently up 63% with over 5,000 students. FTE is up 44%. Currently up 10% on traditional students. Missing around 549 high school students who have not yet applied.

Proposed Board Meeting Topics for FY24

The Board reviewed the proposed Board meeting topics for FY24. The document is fluid, as topics are moved and adjusted throughout the year as necessary.

Key Campus Dates for FY24

Key campus dates for FY23 were distributed.

MACC CIP Prioritization

The MACC CIP Prioritization list was reviewed.

Handbook/Policy Manual/Social Media Demonstration

Executive Director Childs demonstrated the new Employee Handbook and Policy Manual created using Flipping Book to the Trustees.

Executive Director Kirkpatrick introduced Manager Humbel to the trustees. Manager Humbel showed the Trustees some of the highest rated videos and posts on HCC's Instagram page.

Monthly and Special Reports

Financial Report as of August 31, 2023 (ACTION)

Vice President Soeffker-Culicerto gave a brief overview of the financial report. Mr. Snook asked a few general questions about auxiliary numbers. Mr. Snook moved to accept the financial report as of August 31, 2023 as submitted. Mr. Newcomer seconded, and the motion carried by unanimous vote. Mr. Snook also confirmed the audit committee meeting will be held on October 12th at 1 pm.

Special Reports

Early College Degree Program Report

Dean Renninger introduced Director Smith. Director Smith reported on the Early College Program class of 2023. A total of 185 students have graduated from the Middle College since the first graduating class in 2015.

In the cohort for the 2023-2024 academic year are seventy-nine students, thirty of whom are returning seniors, and forty-nine are incoming juniors; coming from various Washington County

high schools, private schools, and home schooled. Director Smith discussed several factors that have boosted the program this year including developments with Maryland Blueprint. Currently there are 68 full-time high school students in addition to the 79 full-time Early College Program students. There are also 380 part time Early College students. Mr. Williamson, Mr. Snook, and Mr. Proctor asked questions pertaining to the number of early college students taking classes in the high school and how theses classes are being run. Interim Vice President Schoenenberger discussed the registration process and the standards of the classes in the high school. Interim Vice President Schoenenberger stated an on campus team has been implemented to work on improving the program with Maryland Blueprint processes for FY25.

Maryland Performance Accountability Report (ACTION)

Dean Ranalli discussed the Maryland Performance Accountability Report. Ms. Lampton moved to approve the report as submitted. Mr. Abraham seconded, and the motion carried by unanimous vote.

There being no further business or discussion, the regular meeting was adjourned at 2:33 pm. The next regularly scheduled meeting will be held on October 17, 2023 in the AC&T Student Center Room 182, unless otherwise noted.
