

**RETIREMENT OF CARLISLE E. MOODY
DEPARTMENT OF ECONOMICS**

Carlisle E. Moody received his B.A. from Colby College with a major in Economics. He earned his M.A. and Ph.D. in Economics in 1966 and 1970, respectively, from the University of Connecticut, where he received a National Defense Education Act Fellowship. Professor Moody started his career as Lecturer in Econometrics at the University of Leeds in England in 1968. He came to William & Mary as an Assistant Professor in 1970, was promoted to Associate Professor in 1975, and Professor in 1989. He served as Chair of the Economics Department from 1997-2003 and spent a semester as a visiting scholar in the Economics Department of the University of Adelaide. He was a Bredin Fellow at William & Mary in 1982.

As a scholar, Professor Moody has published over fifty refereed articles and over twenty other scholarly articles and book chapters. According to Google Scholar, his research has been cited 2853 times. He currently has 18 working papers at the Social Science Research Network, many of which have been accepted in refereed journals, copies of which have been downloaded over 25,000 times and viewed over 100,000 times. He has written three amicus briefs for the U.S. Supreme Court, two of which have been cited by at least one justice and all of which supported the eventual winning side. Professor Moody has also been a consultant to the U.S. General Accounting Office, the U.S. Department of Energy (Energy Information Administration), the Oak Ridge National Laboratory, and the Independent Institute. He has served the Commonwealth of Virginia for many years forecasting the number of new court commitments to help the Department of Corrections plan for future incarceration and the Commonwealth to make the necessary budget decisions.

Professor Moody has immensely enjoyed teaching econometrics, mathematical economics, and time series analysis. He has earned a reputation for teaching rigorous courses at an extremely high level. Students praise his availability and dedication, and his passion for teaching excellence has remained undiminished over time. Through his dedication to excellence, Professor Moody has developed generations of informed citizens and practicing economists in his long career.

Another hallmark of Professor Moody is his exceptionally effective out-of-class mentoring. Colleagues and students alike place great value on their interactions with Professor Moody, and have been deeply impacted by his keen intellect and wisdom, his sense of humor, and his humility.

Moody, expresses its profound appreciation for his many contributions to William & Mary; and approves, with deep gratitude for his fifty-four years of service, a change in status from Professor of Economics to Professor of Economics, Emeritus.
