

# Lee County Administrative Services Committee Meeting Minutes

#### Call to Order

Meeting was called to order at 9:00 a.m., by Chair Chris Norberg.

II. Committee Member Roll Call: Chair Chris Norberg, Vice Chair Danielle Allen, Bill Palen, Nancy Naylor, and Katie White

III. Meeting Attendees and Visitors

IV. Approval of the Minutes from the Previous Meeting - (June 13, 2022)

The minutes from the June 13, 2022, Administrative Services Committee Meeting were approved without modification.

V. Review of Claims Report Provided by the Claims Committee

The committee was provided a report of all the claims submitted and paid for from May 13, 2022 - June 9, 2022, from the County Clerk and Recorder, Treasurer, Regional Office of Education, County Board, IT, Assessor, GIS, and Veteran Assistance.

- VI. Administrator and Department Head Reports
  - A. Regional Office of Education Report

Chris Tennyson was not able to attend the meeting but submitted a comprehensive report from the Regional Office of Education. The full report will be included in the June County Board Agenda Packet.

B. Assessment Office

Jennifer Boyd introduced Sami Elarifi to the committee. Sami has worked in the GIS Department for roughly six (6) weeks.

- He is a professional GIS Specialist with more than fifteen years of experience in implementing GIS technologies in the private and public sector, nationally and internationally, including Homeland Security, Water Recourses, Roads, Mining, and NGO's.
- He received his Bachelor of Science (B.Sc.) in Surveying Engineering from the University of Khartoum, Sudan and his Master of Science (M.Sc.) in Photogrammetry and Geoinformatics from Stuttgart University of Applied Sciences in Germany.
- Sami is very much a team player and due to his qualifications, was able to be productive from day one.

In addition the report she submitted to the committee, Jennifer Boyd reported the following information from the Assessors Office:

- The township books were submitted on June 15, 2022.
- The office is wrapping up their quadrennial township review of Ashton, Bradford, Nachusa, Franklin Grove, Amboy, Sublette, Lee Center, and May.
- The office continues to work on the multi-township redistricting requirements precipitated by results of the 2020 Census.

Carmen Bollman reported the following information from the GIS Department:

- The office worked with the City of Dixon to add sanitary mains to the Water Department web layer. They will also be adding manhole and storm drain layers.
- Sami is working to update a wall map for Dixon Rural Fire Department that will include street indexing.
- The office assisted with the 911 Motorola Software upgrade.
- Continue to work with CloudPoint to get ready for a new server.

Nancy Petersen reported the following information from the County Clerk and Recorders Office, which included the Election Office:

- The Primary Election had a 25.5% turnout (18.1% was early voters), which was the highest in the surrounding areas
- There were 21,612 total voters
- The voting results will be considered official on June 12, 2022

Chris Norberg reported that there were five (5) employees quarantined during the month of June for a combined total of twenty-two (22) days.

## A. 2022 Sexual Harassment Training

Chris Norberg explained that the 2022 Sexual Harassment Training would be sent out to Department Heads on September 1, 2022. The training is required by all Lee County employees. Board Members will also be asked to complete the training.

## B. Committee Assignments / Restructuring

This topic was discussed at the June 29, 2022, Special Executive Committee Meeting. The creation of the Claims Committee has reduced the length of the committee meetings to the point that committees could easily be combined. The committee will be revisiting this topic for the next few months.
