6. (a) Summary of what the rule says and of any proposed amendments including whether the rule implements a state statute for the first time:

Vet 301 describes the application procedures for individuals seeking a license to practice veterinary medicine. The Board of Veterinary Medicine (Board) proposes to readopt with amendment Vet 301.01 on application procedures to incorporate Plc 304 on initial licensure. The Executive Director of the Office of Professional Licensure and Certification (OPLC) was granted rulemaking authority in RSA 310:6, II to adopt rules for application procedures, pursuant to 2023, 235:8, effective July 15, 2023. Vet 301.02 on abandoned applications previously effective August 1, 2019 as an interim rule, and expired on January 28, 2020, is not addressed in this proposal. The Board has not enforced this rule after expiration.

Vet 302 describes the qualifications for licensure to practice veterinary medicine. Vet 303 describes the examination subjects, passing grade, and retention policy for jurisprudence examinations. The Board proposes to readopt with amendment Vet 302.01 on qualifications, and Vet 303.01 on examination subjects, to provide clarity in the introductory language.

Vet 304 describes licensure by reciprocity. The Board proposes to repeal Vet 304 on reciprocity and adopt new Vet 307 on conditional licensure. RSA 332-B:11 on licensure by reciprocity was repealed pursuant to 2024, 274, VI, effective July 1, 2024, and subsequently reenacted as conditional licensure pursuant to 2024, 246:1, effective September 17, 2024.

OPLC was granted authority in RSA 310:17 to issue licenses to professionals who hold an active license in good standing in a jurisdiction with substantially similar requirements as are required in this state, pursuant to 2023, 111:1, effective August 27, 2023.

Vet 305.01 defining "direct supervision", "indirect supervision", and "permittee" was previously effective August 1, 2019, as an interim rule, and expired on January 28, 2020. Vet 305.01 is not addressed in this proposal. The Board has not enforced this rule after expiration.

Vet 306 on fees, previously effective August 1, 2019, as an interim rule, and expired on January 28, 2020, is not addressed in this proposal. The Board has not enforced this rule after expiration. OPLC was granted rulemaking authority in RSA 310:6, I to adopt rules relative to the establishment and collection of the fees set forth in RSA 310:5, I, pursuant to 2023, 235:8, effective July 15, 2023.
