I am current living in Florida and am seeking to reinstate my New Hampshire pharmacist license originally issued in April 1994, expired in April 2004.

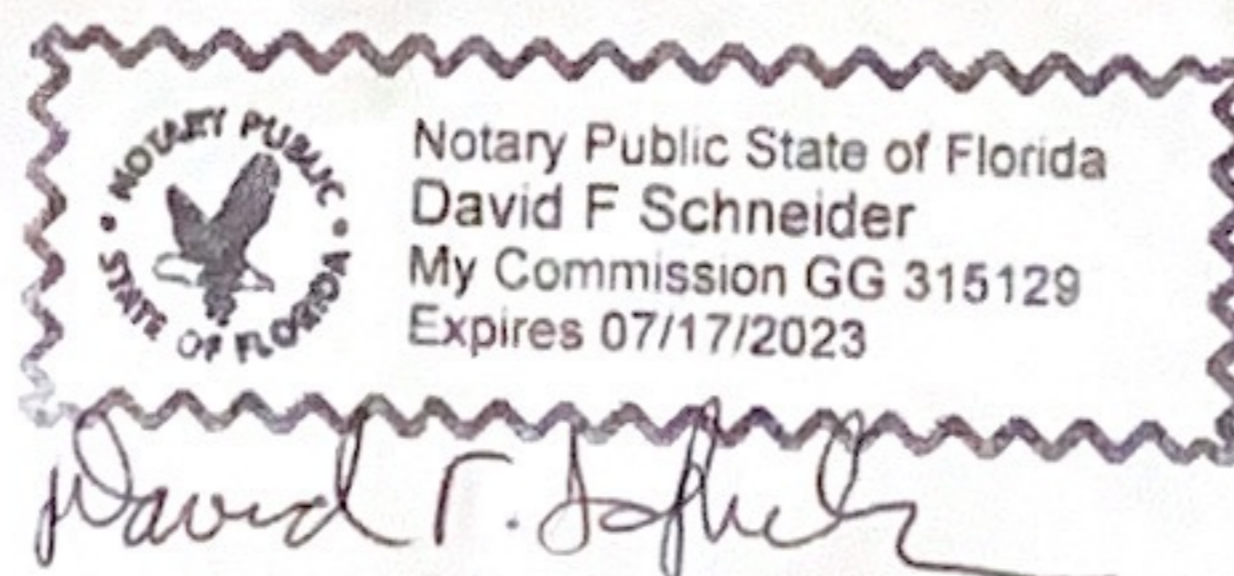

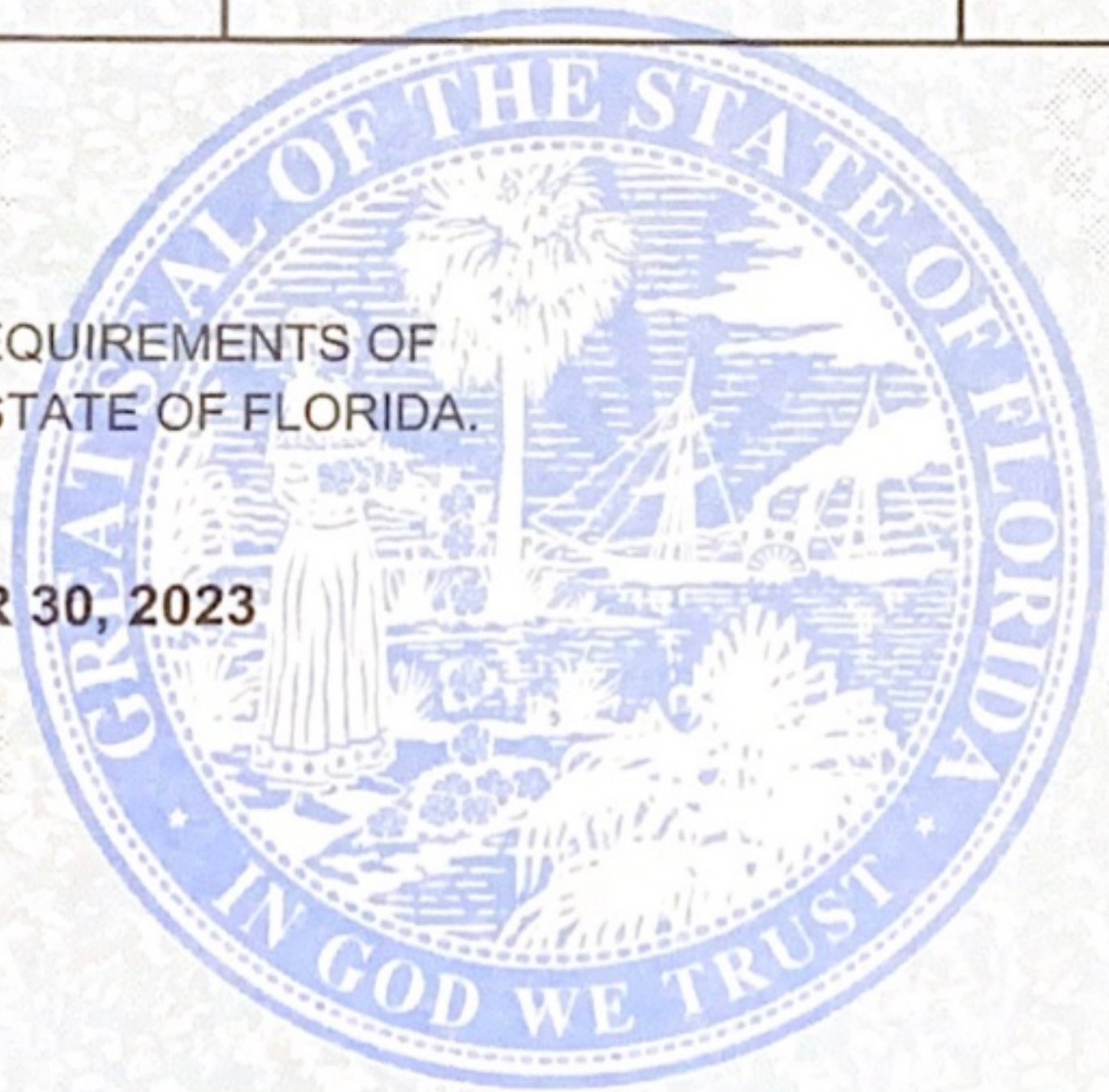

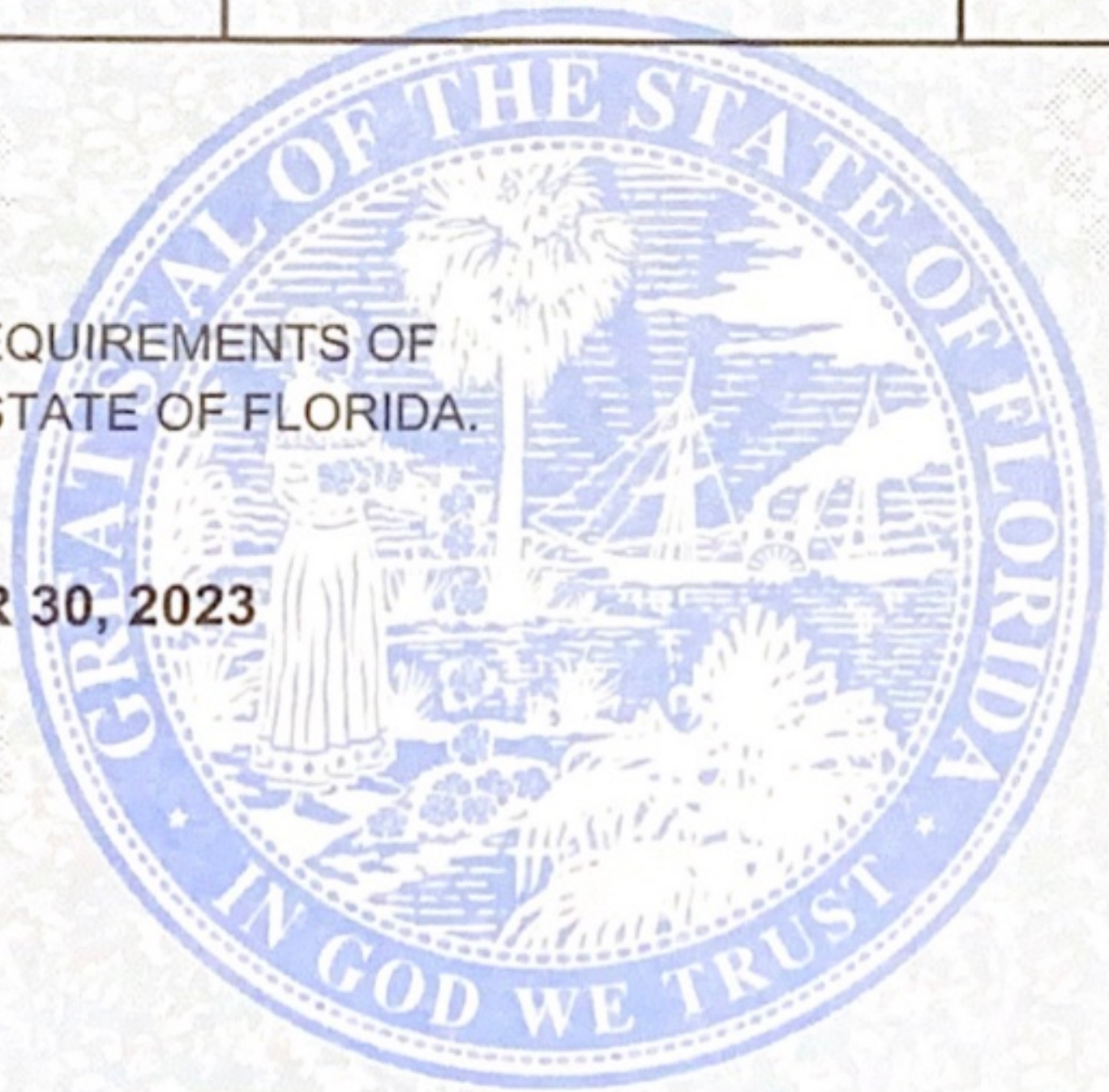
