In the explanation of the verse, the following is stated: “a virtuous person is one who has high moral standards, and acts with integrity, honesty, and morality, and importantly, even when no one is looking.”

The proposed policy put forth by the Administration regarding Transgender students allowed for a male who declared himself as a female to shower and room with female cadets. Thankfully, the BOV saw the repulsiveness of such a proposal.

## Highest Ethical Standard?

Disguised DEI as DOI. The BOV Bylaws, General Order # 1, and the recent mandatory meeting of faculty and staff where the guest speaker promotes herself as a “Diversity Equity & Inclusion speaker, author and researcher” all point to the fact that “DEI is not dead.”

In the recent “summary judgement” hearing regarding the Col. Todd Pegg lawsuit, the judge made the following statement: “You can’t sue them for ***not acting honorably*** (emphasis added).” It should also be noted that in the “Defendant’s (VMI Board of Visitors) Motion for Summary Judgement” filed in March of this year, legal counsel for VMI initially referred to Col. Todd Pegg as “Plaintiff Todd Allan Pegg (‘Pegg’)” and then refers to him repeatedly as merely “Pegg.” Is that showing “respect and dignity” to a man who has served this nation and VMI with distinction?

Although VMI officials don’t tie Critical Race Theory (CRT) to DEI, scholars such as Dr. Carol Swain, experts like Heather MacDonald, think tanks like the Heritage Foundation do. Even the Virginia Association of Scholars had this to say in their January of 2023 report: “***Under the DEI banner***, anti-American racial and sexual politics advance, ***including*** with allied slogans and theories such as ‘white privilege,’ ‘anti-racism,’ ‘***critical race theory***,’ . . .” (emphasis added)

The President of the BOV has asserted the “strong support of freedom of speech,” yet organizations who advocate for freedom of speech have been critical of VMI. In an Alumni Town Hall meeting referencing VMI getting involved with negative articles about the school, he stated: “getting involved directly isn’t going to help our cause.” And yet VMI got “involved directly” when articles appeared in the Cardinal News and Washington Post on the cadets from the Cadet Newspaper receiving a prestigious award from the Virginia Press Association.

On that point, the Superintendent had asserted that no one at VMI had questioned the integrity of those cadets, to which Mr. Teddy Gottwald responded: “General, I disagree with that.” Evidence clearly supports Mr. Gottwald’s statement. The Superintendent had also stated in the Alumni Town Hall mentioned previously: “Probably over a year and a half ago, I gave strong feeling suggesting that we deal with our issues and our disagreements in house. That we were providing fodder, if you will, to the Washington Post.” And yet he took to social media to engage in a personal attack against me, while at the same time disrespecting over 100 former Honor Court members spanning a period of six decades by merely referring to them as “that group,” and the content of the letter as “nothing in it was enlightening.” Respect? Dignity? He was right about one thing. His post provided “fodder to the Washington Post.” One final point, the Superintendent’s Chief of Staff had his honor challenged in an article appearing in the Cadet Newspaper.


