

**WILLIAM & MARY  
FY 2025 GRADUATE AND PROFESSIONAL PROGRAM TUITION**

Consistent with tuition and fee authority granted to William & Mary (W&M) in the Code of Virginia, the attached graduate and professional tuition are recommended for approval by the William & Mary Board of Visitors.

The attached tuition schedules recommend no increase to tuition for general graduate students regardless of domicile status for FY25. Increases proposed to the Part-Time MBA rate brings the Mason School closer to competition within Virginia. All other business rates are held flat due to market pressures and competition from online graduate business programs with lower rates. The Law School has brought LLM rates up to market over the past three years and is recommending a 3.9% increase to address inflationary costs. The new rate for the M.L.S. program was established through a market study and positions W&M as competitive with peers while also reflecting the quality of W&M's education. Lastly, the School of Education is bringing their Online MEd in Counseling up to a competitive market rate over a three year period. The increase from \$725 to \$775 per credit represents year two of the plan to end up at \$825 by FY26.

**WHEREAS**, the proposed increases to graduate and professional tuition result from analysis of the value of programs along with comparison to market competition; and

**WHEREAS**, setting tuition early in the admissions cycle is important to our graduate and professional schools in crafting financial aid packages and optimizing student yield;

**THEREFORE, BE IT RESOLVED**, That the William & Mary Board of Visitors approves the Graduate and Professional Tuition outlined in Tables 1-3 for FY25;

**THEREFORE, BE IT ALSO RESOLVED**, That the William & Mary Board of Visitors will adopt comprehensive fees for students of all schools at its regularly scheduled meeting in April 2024.
