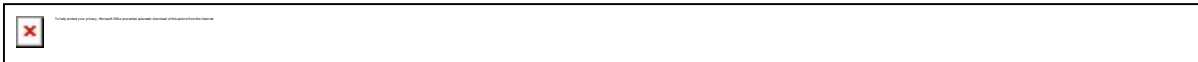

FSMB Chair Katie Templeton, JD, Chair-elect George Abraham, MD, and I are in New York today for a meeting of the Tri-Regulator Collaborative leadership, joining colleagues from the National Association of Boards of Pharmacy (NABP) and the National Council of State Boards of Nursing (NCSBN). Comprised of the FSMB, NABP and NCSBN, the Collaborative explores opportunities for interprofessional cooperation and collaboration between the nation's state medical, nursing and pharmacy boards.

Among the topics for discussion are the Opioid Regulatory Collaborative (ORC), an update on the Tri-Regulator/ORC Conference scheduled for March 2025, efforts by states to streamline the licensing of foreign-trained international medical graduates, Interstate Compacts, and IV hydration and ketamine clinics.

Representing the NABP are Executive Director/Secretary Al Carter, MS, PharmD, RPh, President Jeffrey Mesaros, PharmD, JD, RPh, and President-elect Bradley Hamilton, BSPharm, RPh. Joining us from the NCSBN is CEO Phil Dickinson, PhD, RN.
