## I. CALL TO ORDER

## B. City Manager

Zavadil provided a written report and was available for questions. CM Melovidov asked for an update on Electric Utility Unit 6 repairs. There is no update on if Trident had an extra part to assist with repairs.

## E. Project/Grants Specialist

Since the last meeting, there has been no new awards, 4 applications totaling a request of $\$ 696,010$ have been submitted, 23 applications totaling $\$ 62,370,962$ are pending and 7 applications are under development. CM Melovidov asked for clarification on the solar panel arrays and battery storage system. The CPRG focuses on 2.5-megawatt battery storage system and enhancing controls and other things for TDX power wind generators and 3 additional wind
generators that would be integrated into the grid. The battery system allows diesel generators and wind to work together, controls and stabilizes. The batteries would distribute the power to the grid. The 3 new wind generators would be newer models and would not have the box on top. The plan it to, with the upgrades, take in more alternative energy. The goal with the EPA grant is to reduce emissions and eventually shut off generators, to burn less fuel, with battery system powering the grid.

## F. Kuna Engineering

Joe Rolfzen and team with Kuna Engineering presented on SS4A Comprehensive Safety Action Plan. They hosted a community meeting and met with various entities to gather public input to develop information related to transportation safety. They traveled the roads, looking at physical issues including guard rails, signage, amount of lighting, drainage and impacts on safety. The plan's efforts are focused on the safety of existing roads and trails.

## VIII. NEW BUSINESS

## A. Resolution 24-10 - Authorizing the City to Apply for the USDOT Maritime Administration FY24 Port Infrastructure Development Program Grant <br> CM Edenshaw MOVED to approve. Seconded by CM Porath.

This is the fourth year in a row to apply. Asking for planning and construction for City South Dock and berthing dolphins. This grant has a clause where as a rural community with a small port project under 11.2 million there is no match required and a cost benefit analysis does not need to be submitted which alone would cost 20-25 thousand dollars.

Motion to approve Resolution 24-10 was carried by Roll Call vote of 6 Ayes.
