Pursuant to due call and notice thereof, a regular meeting of the City Council of the City of Princeton, Mille Lacs and Sherburne Counties, Minnesota, was duly held at the City Hall on August 8, 2024 at 7:00 p.m. for the purpose, in part, of calling a public hearing on the proposed modification of Municipal Development District No. 9, the adoption of a modification to the Development Program for Municipal Development District No. 9, the establishment of Tax Increment Financing District No. 9-5 within Development District No. 9, and the proposed adoption of the Tax Increment Financing Plan relating thereto.

RESOLUTION CALLING PUBLIC HEARING ON THE PROPOSED  
MODIFICATION OF MUNICIPAL DEVELOPMENT DISTRICT NO. 9; THE  
ADOPTION OF A MODIFICATION TO THE DEVELOPMENT PROGRAM FOR  
MUNICIPAL DEVELOPMENT DISTRICT NO. 9; THE PROPOSED  
ESTABLISHMENT OF TAX INCREMENT FINANCING DISTRICT NO. 9-5  
WITHIN DEVELOPMENT DISTRICT NO. 9; AND THE PROPOSED ADOPTION OF  
A TAX INCREMENT FINANCING PLAN RELATING THERETO

BE IT RESOLVED by the City Council (the "Council") of the City of Princeton, Minnesota (the "City"), as follows:

1. Public Hearing. This Council shall meet on October 24, 2024, at approximately 7:00 p.m., to hold a public hearing on the following matters: (a) the proposed modification of Development District No. 9; (b) the proposed adoption of a modification to the Development Program for Development District No. 9; (c) the proposed establishment of Tax Increment Financing District No. 9-5 within Development District No. 9; and (d) the proposed adoption of a Tax Increment Financing Plan relating thereto, all pursuant to and in accordance with Minnesota Statutes, Sections 469.124 through 469.133, both inclusive, as amended, and Minnesota Statutes, Sections 469.174 through 469.1794, both inclusive, as amended (collectively, the "Act").

2. Notice of Hearing; Filing of Program and Plan. The City Clerk is hereby authorized to cause a notice of the hearing, substantially in the form attached hereto as Exhibit A, to be published as required by the Act and to place a copy of the proposed Development Program and the proposed Tax Increment Financing Plan on file in the City Clerk's Office at City Hall and to make such copies available for inspection by the public.

3. Consultation with Other Taxing Jurisdictions. The City Clerk is hereby directed to mail a notice of the public hearing and a copy of the proposed Development Program and the proposed Tax Increment Financing Plan to Mille Lacs County and Princeton Public Schools - District 477 informing those taxing jurisdictions of the estimated fiscal and economic impact of the establishment of the proposed tax increment financing district.
