PURPOSE

Board Policy 1A.1 Minnesota State Colleges and Universities Organization and Administration, Part 6. Board Policies and System Procedures requires board review and approval of proposed board policy changes and that each board policy is reviewed at least once every five years.

BACKGROUND INFORMATION

The proposed amendment consists of deleting outdated background information and the term "regional" throughout the policy, replacing the definition for Higher Learning Commission, and clarifying "program accreditation" in Part 4, Subp. B.

3 Part 1. Purpose

4 To establish accreditation requirements for colleges and universities.

5

6 Part 2. Background

7 Higher education institutions demonstrate that ~~the college or university they~~ and their
8 educational programs meet minimum standards through accreditation. Accreditation can be
9 attained at the institutional or programmatic level. Once achieved, accreditation must be
10 ~~reaffirmed~~renewed periodically to ensure that the quality of the institution and educational
11 programs is maintained.

13 ~~In order for students to receive federal student aid from the U.S. Department of Education for~~
14 ~~postsecondary study, the institution must be accredited by a federally recognized accreditor.~~

15

16 ~~While there are both regional and national accreditors, regional accreditation uses more~~
17 ~~stringent standards of quality. Credits earned from regionally accredited institutions are more~~
18 ~~widely accepted and more easily transferable than credits earned at nationally accredited or~~
19 ~~non-accredited institutions.~~

21 Part 3. Definitions

22

23 Accreditation

24 A process and a status that assures higher education institutions and programs meet a set of
25 standards developed by peers.

26

27 a. Institutional accreditation

28 Accreditation of an ~~college or university~~ entire institution is determined by institutional
29 accreditors (formerly regional or national accreditors), indicating that ~~each of the college or~~
30 university an institution's parts is achieving contributing to the achievement of the
31 institution's mission, ~~and~~ objectives, and the accreditor's standards.

32

33 b. Program/specialized accreditation

34 Accreditation of ~~an institution's~~ college or university programs that involves examination
35 of the individual academic units, programs, or disciplinary offerings to ensure they are
36 providing students with a quality education in a particular area of study. Programmatic
37 accreditation may be required in some fields for graduates to seek licensure or
38 certification. Programmatic accreditation in other fields serves to provide a recognition
39 of quality.

41 Higher Learning Commission (HLC)

42 An institutional accreditor recognized by the U.S. Department of Education. HLC accredits
43 degree-granting institutions of higher education in the United States. ~~The Higher Learning~~
44 ~~Commission (HLC) is an independent corporation that is one of the regional institutional~~
45 ~~accreditors in the United States. HLC accredits degree-granting post-secondary educational~~

46 institutions in the North Central region (including Minnesota) and is recognized as a regional
47 accreditor by the Secretary of Education.

48
49 **Regional accreditation**

50 The accreditation process used or status granted by one the federally recognized regional
51 accreditors in the United States.

53 **Part 4. Accreditation**

54
55 **Subpart A. Regional Institutional Accreditation**

56 Colleges and universities shall achieve and retain regional accreditation through the Higher Learning
57 Commission. Any college or university that does not maintain accredited status with the Higher
58 Learning Commission may be subject to loss of degree granting authority.

59
60 **Subpart B. Program Accreditation**

61 For programs that have an accreditation and for which people working in that field must be
62 licensed or certified for employment, colleges and universities shall achieve and maintain
63 accreditation for those programs (i.e., law enforcement peace officer, nursing, dental hygiene,
64 etc.).

65
66 For fields that do not require licensure or certification, colleges and universities may obtain are
67 encouraged, though not required, to obtain voluntary program accreditation where appropriate and
68 aligned with the mission of the college or university (i.e., automotive technician, business,
69 chemistry, etc.).

70
71 **Part 5. Report to the Board of Trustees**

72 The chancellor shall provide an annual report to the Board of Trustees on the status of the regional
73 accreditation for each college and university. College and university presidents shall submit an annual
74 update to the chancellor, or chancellor's designee, on the status of their regional accreditation.
