

On April 20th, 2022 physician ID# 635022, was summarily suspended at Broward Health North in accordance with the Medical Staff Bylaws. The summary suspension was submitted to the Medical Executive Committee at an emergency meeting held on April 26th, 2022, the Medical Executive Committee decided to continue the summary suspension for further investigation and for MEC to reconvene within fourteen (14) days to review and consider action taken as well as review findings made during the investigation and request physician ID# 635022 attendance to discuss the summary suspension.

On May 2nd, 2022, the Medical Executive Committee met, physician ID# 635022 failed to appear. After further discussion, the Medical Executive Committee ratified to continue the summary suspension with the recommendation for revocation of membership/privileges of physician ID#635002.

On May 3rd, 2022, a letter was sent to the Practitioner regarding the MEC's findings and recommendation and notifying the Practitioner of his right to a fair hearing. The Practitioner failed to request a fair hearing and, as such, the Practitioner's fair hearing rights were waived.
