OCURRENCE CATEGORY CY22Q1

Total number of incident reports decreased by 2%. Quarter 1 has a total of 801 incidents compared to 817 in Quarter 4. Security occurrences decreased from 299 to 250 while patient care occurrences decreased from 285 to 249. Medication occurrences increased from 43 to 60 and falls increased from 42 to 65. The overall Near Miss occurrences during Quarter 1 CY 22 is 16, or 2% of overall occurrences. The goal continues to be increased reporting to discern trends in order to implement risk reduction measures.

MEDICATION VARIANCES CY22Q1
 Medication Variances increased by 40%, from 43 to 60. The Cancer Center began entering more medication variance reports to track and trend. This increase is likely due to increased reporting rather than purely more occurrences. Risk, nursing, and administration collaborate monthly to discuss medication variances, trends, and lessons learned from medication variances. Lessons learned are based on trends or high-risk/frequency items that can be avoided. They are then distributed to staff by various methods such as created into videos produced and starred in by pharmacy staff, emailed to all BHN in CEO newsletter, or played on the tv outside of main hospital elevators. No adverse outcomes. Goal continues to be increased reporting.

SURGERY RELATED ISSUES CY22Q1
 There was a 31% increase from quarter 4 as surgery-related issues went from 13 to 17. One retained foreign body incident was a chest port in which the catheter was "embolized" into the subclavian vein in a patient with "Port Pinch Off Syndrome". Catheter was then retrieved by IR. Second retained foreign body was nasal packing that was surgically removed likely from patient packing own nose during epistaxis. Two additional retained foreign bodies are listed below in the Code 15 section. Surgery Related incidents are referred to quality as deemed appropriated for review.

❖ Code 15 Reported:

- 43 year-old female admitted with abdominal pain. CT abdomen showed large abdominal/pelvic mass exhibiting iatrogenic/man-made features. Patient taken to OR by general surgeon and underwent an exploratory laparotomy, lysis of adhesions, and small bowel resection. A foreign body was found on intra-abdominal wall with dimensions of 45x32x2cm and features consistent with a towel. Patient previously had a hysterectomy in Mexico 7 years prior.
- 32 year-old female presented to ED in sickle cell crisis. A CT Angio revealed a wire in the hepatic vein. Patient taken to IR and removed a fractured guidewire. Upon chart review, wire originated from port placement at BHMC in December 2019.
