SUBJECT: Approval to enter into a 2-year agreement up to the 84th percentile with Dr. Rubens Sievert to provide Endocrinology services.

BACKGROUND

The North Broward Hospital District, d/b/a Broward Health is seeking to enter into a two-year employment agreement up to the 84th percentile with Dr. Rubens Sievert. Dr. Rubens Sievert obtained his Doctor of Medicine at Universidad Federal de Santa Catarina, Florianopolis, SC-Brazil. He then completed an Internal Medicine Residency and Internship at Long Island College Hospital, Brooklyn, NY. He then completed an Endocrinology and Metabolism Fellowship at Montefiore Medical Center, Bronx, NY in 1995. Dr. Sievert is Board Certified in Endocrinology, Diabetes and Metabolism with over 27 years of experience and a long-term member of the Broward Health medical staff in good standing.

Dr. Sievert joined Broward Health Physician Group in 2010 and has been instrumental in serving the community.

It is critical for the community and healthcare system to employ endocrinologists to meet the current and future growing demands. As a safety net hospital, the District is obligated to provide services to meet the community needs.

ACTION/PROJECT DESCRIPTION

We are requesting that the Board of Commissioners approve entering a two -year contract with Dr. Rubens Sievert up to the 84th percentile.

An independent third-party appraisal report determined that the proposed arrangement is commercially reasonable and the compensation is within fair market value (FMV). Specifically, the proposed base compensation approximates the 76th percentile with overall maximum compensation at the 84th percentile.

JUSTIFICATION

Broward Health has documented and objectively determined that there is a legitimate business purpose for the services of a qualified endocrinologist to provide clinical care at Broward Health North and Broward Health Coral Springs.

The community needs assessment identifies this specialty as a critical priority with a shortage of endocrinologists in Broward Health North's service area and in Broward Health Coral Springs' service area.

It is critical for the community and healthcare system to employ endocrinologists to meet the current and future growing demands. As a safety net hospital, the District is obligated to provide services to meet the community needs.

STAFF RECOMMENDATION

Therefore, it is requested that the Board of Commissioners of the North Broward Hospital District authorize the District to enter into a two-year employment agreement with Dr. Rubens Sievert up to the 84th percentile for the provision of endocrinology services for Broward Health.
