- A. WHEREAS, the City of Princeton (the "City") and Phoenix Capital, LLC (the "Developer") has entered into a Development Agreement (the "Development Agreement") in connection with the construction of a 66-unit residential rental housing facility (the "Project"); and
- B. WHEREAS, the City, upon compliance by the Developer with the provisions of the Development Agreement, will issue the Tax Increment Revenue Note (Briggs Apartment Project Phase III) pursuant to the Development Agreement that is payable to the Developer (the "TIF Notes"); and
- C. WHEREAS, the Developer is seeking to finance the Project with U.S. Bank, National Association (the "Bank"), and the Bank is requiring the execution of a Collateral Assignment of Development Agreement TIF Note (the "Collateral Assignment"); and
- D. WHEREAS, a draft of the Collateral Assignment has been submitted to the City Council for approval:

- 1. The City Council hereby approves the Collateral Assignment in substantially the form submitted, and the Mayor and the City Administrator are hereby authorized and directed to execute the Collateral Assignment on behalf of the City. - 2. The approval hereby given to the Collateral Assignment includes approval of such additional details therein as may be necessary and appropriate and such modifications thereof, deletions therefrom and additions thereto as may be necessary and appropriate and approved by

the City officials authorized by this resolution to execute the Collateral Assignment. The executio
