



# Special Lee County UTV Committee Meeting

### I. Call to Order

The meeting was called to order at 3:17 p.m., by chair Jack Skrogstad.

### II. Roll Call - Chair Jack Skrogstad, Tom Wilson, Danielle Allen, Kasey Considine, Keane Hudson

Danielle Allen was absent. Kasey Considine attended the meeting via Zoom video conferencing. All other member attended in person.

### III. Visitors

Charley Boonstra (State's Attorney), Wendy Ryerson (Administrator), and Becky Brenner (Board Secretary).

### IV. Approval of Minutes from the Previous Meeting - (May 27, 2022)

The minutes from the May 27, 2022, Special Lee County UTV Committee Meeting were approved as presented.

### V. Old Business

#### A. UTV Ordinance Discussion

All discussion during the meeting fell under the New Business item of revised language.

### VI. New Business

#### A. Language Revisions to the Current Draft Ordinance

Jack Skrogstad explained that while talking with other townships and municipalities about adopting the Lee County Ordinance, several scenarios came to light that the ordinance did not address. It was the desire of the committee to address these scenarios with the following motions:

- Because registration fees would not be the same throughout all areas in Lee County, the following motion was made to prevent owners from only registering their UTVs in jurisdictions where the fees were less expensive than where they resided.

**Motion** to add the following verbiage to the UTV ordinance: If registering owner lives within a jurisdiction of a municipality that already has a UTV ordinance, they must register the UTV with that municipality and pay the fees required. **Moved** by Tom Wilson. **Second** by Kasey Considine. **Motion** passed unanimously by voice vote.

**Motion** to add the following verbiage to the UTV ordinance: If the registering owner lives outside a jurisdiction of a municipality that has a UTV ordinance or within a municipality that does not have a UTV ordinance, then the registering owner must register with Lee County and pay the fees required. **Moved** by Tom Wilson. **Second** by Kasey Considine. **Motion** passed unanimously by voice vote.

**Motion** to add the following verbiage to the UTV ordinance: If a UTV owner intends to operate on County roadways, the owner must register with Lee County. Fees will be waived if the UTV owner has a valid registration with another jurisdiction with Lee County. **Moved** by Kasey Considine. **Second** by Tom Wilson. **Motion** passed unanimously by voice vote.

**Motion** to send the UTV ordinance back to the Public Safety Committee with the language changes. **Moved** by Tom Wilson. **Second** by Kasey Considine. **Motion** passed three (3) in favor, one (1) opposed.

VII. Executive Session

No executive session was requested.

VIII. Next Meeting

No future meeting date was scheduled.
