










#### **KCTCS PROGRAM MANAGEMENT**

#### KCTCS ONLINE LEARNING ASSESSMENT (KOLA) PLAN

The KOLA Plan was implemented in Spring 2023 as a system-wide approach to online course quality. The plan includes three components:





- 1) Faculty Development on the KCTCS Essential Standards (KES)
- 2) Faculty Review of Online Courses using the KES
- 3) Validation of Course Reviews Completed by the Colleges using the KES



## FACULTY DEVELOPMENT ON THE KCTCS ESSENTIAL STANDARDS (KES)

Following the KCTCS Online Learning Assessment (KOLA) plan, **all adjunct** faculty and any newly hired full-time faculty will complete KES training no later than the end of the academic year 2024-2025.




61% of adjunct faculty have completed the KES training



# KCTCS ESSENTIAL STANDARDS (KES) SELF-REVIEW

Following the KCTCS Online Learning Assessment (KOLA) plan, **all faculty teaching at least one online course must complete a KES self-review of their courses at least once every third year.** Colleges are responsible for establishing their internal timeline for KES self-reviews, and most have connected it with their internal three-year assessment strategies for online learning.



**51%** of adjunct faculty have completed at least one KES course review







# **KES SYSTEM-WIDE ASSESSMENT**

Validation of course reviews completed by colleges using the KES

- . The KCTCS Online Learning Peer Team conducted KES validation in Spring 2023 and 2024.
  - Going forward, all validation reviews will be conducted every other year.
- . The next date for review is Spring 2026.

#### Fall 2024 – Overview

- Preliminary KCTCS enrollment for Fall 2024 is 84,125, an increase of 5,354 students or 6.8% compared Fall 2023.
  - This is the highest total enrollment across KCTCS in a decade (since Fall 2014).
- Credential-seeking enrollment increased by 6.6% for Fall 2024 compared to Fall 2023.
  - While every KCTCS college experienced growth in credential-seeking enrollment compared to Fall 2023, as a system, credential-seeking enrollment has not yet recovered to pre-COVID levels.





 Total Enrollment is up at fifteen colleges. Ashland held very steady – down seven students compared to Fall 2023.



#### Fall Enrollment Trend – by Student Type








- Fall Enrollment Trend National Comparison
- Except for Fall 2020, the growth at KCTCS in every fall semester from Fall 2018 to the present has surpassed the national average for public 2-year institutions.
- The trend continues this fall, with KCTCS showing an increase in total enrollment of 6.8% compared to a preliminary 4.7% increase nationally.

#### Spring 2025

- As of November 15<sup>th</sup>, Spring 2025 enrollment is 29,929, an increase of 4,474 students or 17.6% compared to the same time last year.
  - Total enrollment is up at thirteen colleges.
- This early in the registration cycle, the majority of the enrollment is credentialseeking - 22,135 students. This represents an increase of 2,503 students or 12.7% compared to the same time last year.
  - Credential-seeking enrollment is up at fifteen colleges.

\* KCTCS is still very early in the Spring 2025 registration cycle. Enrollment will more than double before the official snapshot.


