STATE BOARD FOR COMMUNITY COLLEGES AND OCCUPATIONAL EDUCATION March 13, 2024

TOPIC: Legislative Update

EXPLANATION:

(Report generated on March 7, 2024.) The second regular session of the 74th General Assembly convened on January 10th and is now halfway through the 120- day legislative session. On March 13th, it will be Day 64 of the session.

Since the legislative team last reported to the Board in February, CCCS has provided testimony on several occasions for various bills, engaged in three more press conferences, and provided drafting support on bills of high priority to the Governor and General Assembly leadership to strengthen the state's workforce.

In late February, the Joint Budget Committee (JBC) began figure setting for various departments. Figure setting for higher education is scheduled for the first week of March, but final funding recommendations won't come until after the March revenue forecasts which are scheduled to come out on March 15th. After reviewing the two forecasts, one prepared by Legislative Council Staff and the other prepared by the Governor's Office of State Planning and Budget, the JBC will select one of the forecasts to build the state budget against. The JBS's state budget, referred to as the "Long Bill," will then go through the legislative process starting in late-March through mid-April.

Update on CCCS Priority Bills:

<u>SB24-051 Adult Education</u> passed General Assembly in late February and has been sent to the Governor for signature!

- Sponsors: Senators Rachel Zenzinger and Barbara Kirkmeyer and Representatives Cathy Kipp and Marc Catlin.
- Bill Summary: CCCS initiated this bill to amend implementation provisions, granted by Senate Bill 22-007, to allow the governing board for community colleges and board of trustees for local district colleges to set standards for high school graduation requirements. The legislation allows the flexibility needed for community colleges and local district colleges to develop customized curriculum relevant to adult learners and ability to couple a high school diploma with a career and technical education credential. The bill also allows CDE to roll forward unexpended and unencumbered funds for the adult education and literacy grant program.

<u>SB24-104 Career and Technical Education & Apprenticeships</u> passed the Senate Business, Labor, & Technology Committee on 2/13 unanimously, 7-0! Since this bill has a fiscal note, it requests state General Funds appropriations, the bill now heads to the Senate Appropriations Committee where it will likely wait until the budget is determined in March.

- The bill provides resources for CCCS's Career & Technical Education (CTE)
 Office to work with the Colorado Department of Labor and Employment's
 (CDLE's) State Apprenticeship Agency (SAA) to align the high school CTE
 system and registered apprenticeship system for programs related to
 infrastructure, advanced manufacturing, education, or health care. The bill also
 requires an expansion of aligned pathways, prioritizing "top jobs" as identified in
 Colorado's annual talent pipeline report.

SB24-164 Institution of Higher Education Transparency Requirements, referred to as the "Student Bill of Rights" was initiated by the Department of Higher Education. CCCS has been an engaged partner throughout the drafting phase, advocating for language to strengthen and establish structures for better tracking and reporting for transfer pathways. The legislation seeks to address existing gaps and ensure the integrity of transfer initiatives. The bill also increases student access to information, including costs transparency, financial aid, and transfer of credits to a new institution, to help students make informed decisions and empower them to navigate their educational journey with confidence

Update on CCCS Controlled Maintenance and Capital Projects:

In February, the Capital Development Committee (CDC) and the Joint Technology Committee (JTC) submitted their respective funding recommendations for FY-25 projects to the JBC.

CDC's prioritization yielded recommendations for funding the entire list of controlled maintenance Levels 1 (61 projects total, of which 15 projects are for CCCS/Colleges totaling \$18.8M) and a partial list of Level 2 (10 projects, of which 2 projects are for CCCS Colleges totaling \$1.5M). For capital construction, only Colorado Northwestern Community College's capital renewal project for the Rangely Campus (\$3.6M) was recommended for funding. Trinidad State College's capital project was listed "below the line" but TSC's capital construction project is now part of HB24-1231 State Funding for Higher Education

<u>Projects</u>, where it will likely receive state funding for the full project (\$20M). Unfortunately, Pikes Peak State College's capital construction project for a first responder training facility (\$40M) was not recommended for funding, but CCCS will continue to advocate for their project.

While the Governor recommended funding for both Front Range Community College's and Otero College's capital IT projects, both were not recommended by the JTC for funding. Again, CCCS will continue to advocate for funding these projects.

Monitored Bills:

As of March 7th, over 530 bills have been introduced and CCCS is tracking over 40 bills. The table below lists bills that CCCS is tracking.
