- B. ACADEMICS
  - 1. LCAP Mid-Year Review (Presenters: Valerie Royaltey-Quandt)

Valerie gave a mid-year, high-level breakdown of our LCAP.

LCAP Goal 1 Highlights: We saw new curriculum adoptions, ELA curriculum pilots, ECMS increase in all student subgroups in ELA, EPHS increase in EL and SED subgroups in ELA, AR increase in SWD in ELA and Math, Increased support and training for NDL teams, Robust summer school program 2023, and AVID learning strategies & collaborative instructional strategies.

LCAP Goal 1 Opportunities: Math intervention and support, Increase academic interventions and support in all content areas, and Possibilities for learning acceleration supported by ELOP.

LCAP Goal 2 Highlights: Committed professional development strands for Designated and Integrated ELD for all content area teachers, Instructional coaching, ECMS and AR

increase in multilingual learners making progress, as well at "At-Risk" (4-5 yrs) and LTELS (6+ yrs).

LCAP Goal 2 Opportunities: "At-Risk" and LTEL student progress across DCP, Continued Designated and Integrated ELD support with new curriculum.

LCAP Goal 3 Highlights: EPHS: Graduation Rate (Overall increase, with EL, Hisp/Lat & SED subgroups increased, Increase in all subgroups meeting A-G), ARHS: Graduation Rate (Overall increase, with Hisp/Lat subgroups increased, Increase in all subgroups meeting A-G, SED & Hisp/Lat high for CCI), New CTE courses at both high schools, High school advisory alignment and collaboration. Middle school AVID advisory curriculum implementation

LCAP Goal 3 Opportunities: Seal of Biliteracy, CTE, Support for SWD

LCAP Goal 4 Highlights: Increasing teachers with credentials, permits and internships, Support with credentialing, coaching, induction and new teacher training, and School culture and climate support and attention

LCAP Goal 4 Opportunities: Integration of DEI work

LCAP Goal 5 Highlights: Restorative Practices DCP-wide, continuing year two implementation with site teams on a three-year plan, Decrease in suspension rates and no expulsions at DCP YTD, Increase in social emotional counseling, Student Deans continuing in positions of support, Improved attendance compared to Fall 2023, and Aligned advisory expectations.

LCAP Goal 5 Opportunities: Deans have been working with Dir of Student Services on aligning chronic attendance support systems, Identification of foster and homeless youth, Alignment of systems across DCP, and Family participation in school committees (ELAC, SSC).

#### 2. EL Task Force Report (Presenters: Lynnette Hawkins)

Lynnette gave a report on the EL Task Force. They completed 2 of 3 Fall recommendations (i.e. By September 26, the DLDS will record and share with teachers a webinar modeling how to access and interpret growth trends (longitudinal data) for English learners' language development and how to use the data to plan Designated and Integrated ELD. And, By December 1, members of the EL Task Force will interview at least 4 English learners from each site, including at least one student who is a newcomer and at least one student who is a long-term English learner, to learn about their experiences at DCP.)

She outlined 3 recommendations to Leadership

- Sites will prioritize lesson planning for Designated and Integrated ELD by scheduling at least 30 minutes each month for collaborative planning during PD time. (repeat recommendation)
- DCP Leadership will focus more on increasing student production of academic language (including overlap with AVID goals) during leadership meetings, orgwide PD, and site PD.
- Director of Special Ed, in partnership with the Director of Learning Design & Systems and Site Administrators, will develop and train partners on a clear process for redesignating students who are dually identified and ensure that teachers understand why some students require alternate pathways.
