# **INTRODUCTORY REMARKS**

Mr. Kendrick F. Ashton, Jr. called the Committee for the Student Experience to order at 4:31 p.m. and provided an overview of the agenda.

#### STUDENT AFFAIRS REPORT

Dr. Virginia M. Ambler, Senior Vice President for Student Affairs & Public, provided an update on the campus climate, specifically as it relates to the crisis in the Middle East, and spoke about activities students are participating in on campus. Dr. Ambler also provided an update on William & Mary's Democracy Initiative, and the Housing & Dining Comprehensive Facilities Plan. She highlighted the West Campus Site, where 900 beds will be constructed as well as a new dining facility, and the Jamestown East Site, home of a new residence hall. Dr. Ambler also showed renderings of the planned pedestrian bridge that will connect the two sides of campus. Lastly, she reminded the Committee of the hard hat tour of Monroe Hall that will take place at 8:00 a.m. on Friday, April 26.

A discussion ensued regarding the Democracy Initiative, the new dining vendor, and opportunities for students to interact with the administration.

Mr. Ashton provided a brief update on Athletics and noted that after a discussion with the Rector there will be an athletics deep dive at the annual Board retreat in July. Mr. Ashton provided a brief overview of the lunch that took place earlier in the day with the full Board, student athletes, coaches and athletics leadership. He highlighted various academic achievements of William & Mary athletes, the recent dedication of the Jill Ellis Field and Goody Tyler Scoreboard at the 1987 Women's Soccer Team Training Center, retirement of Peel Hawthorne, and the William & Mary Athletics Hall of Fame Class of 2024. Mr. Ashton also noted the recent hire of Brian Earl, the new coach for men's basketball.
