Arthur Newell, appointed in July 2020.

Mr. Newell is a banker and community leader. He was a past chair and current board member of the Utah Valley Chamber of Commerce, past chair and board member of Mountainland Technical College, past chair and current board member of the Alpine School District Foundation, Utah Valley University Community Advisory Board, and Business Advisory Board. Mr. Newell has a bachelor's degree in finance from Brigham Young University and an MBA from the University of Utah; he is also a graduate of the Pacific Coast Banking School at the University of Washington.

Lori Chillingworth, appointed in August 2019.

Ms. Chillingworth retired from Zions Bancorporation, where she served as director of Enterprise Business Banking. Previously, Ms. Chillingworth served as chief credit administrator for Small Business at Zions Bancorporation and executive vice president of Zions Bank's Small Business Division. Ms. Chillingworth launched the Women's Leadership Institute in January 2015 and currently serves on the Executive Board. Chillingworth is a graduate of the Pacific Coast Banking School, the American Institute of Banking, and the Northwestern Bank Leadership Program.

Lisa-Michele Church, appointed in October 2013.

Ms. Church has spent 30+ years of public and private service as an attorney and community activist. She served as vice president/general counsel for a Utah-based Fortune 500 company and in the cabinet of two Utah governors. As executive director of Utah's Department of Human Services, Ms. Church oversaw 5,000 employees and a \$700 million annual budget. Following that service, she was appointed as the administrator for Utah's juvenile court system. Ms. Church has served on the Dixie State University (now Utah Tech University) Board of Trustees.

Palmer DePaulis, appointed in November 2022.

Mr. DePaulis had a long career in both the private and public sectors. He started his career as a teacher at Judge Memorial High School and then worked as a district claim manager for the Allstate Insurance Company. He served on the Salt Lake City Council and became Mayor of Salt Lake City from 1985 to 1992. Mr. DePaulis was chief of staff for Attorney General Jan Graham and then served under four governors until he retired in 2013.

He is the former chair of the Investment Advisory Committee for my529 and serves on the board of trustees for the Utah School & Institutional Trust Funds Office. He formerly worked on the Washington, D.C., staff of the late Sen. Robert Bennett. Mr. Lunt graduated magna cum laude with university honors from Brigham Young University with a degree in economics. He later received an MBA in Finance and International Business from New York University.
