Recommendation that the Broward College District Board of Trustees authorize the standard agreement (purchase order) with the University Aviation Association (UAA) for Membership and Renewal Dues from July 2024 to July 2025 (FY2024-2025) for the Aviation program. Fiscal Impact: \$575.00.

What is the purpose of this contract and why is it needed? University Aviation Association (UAA) membership is important for the Aviation Department as it creates opportunities to meet people in the field and creates internship opportunities for students in addition to providing visibility for Broward College in the Aviation community.

What procurement process or bid waiver was used and why? Small purchase for Category One (\$0.00-\$10,000) per College Procedure A6Hx2-6-6.34 was used, where there are no formal or informal competitive requirements for goods and services acquired by the College at this dollar threshold. Membership dues, per the Florida Statute 119.01 (3) requires that all financial, business and membership records held by the organization in relation to the individual(s) or organization(s) for whom a purchase order is being issued are to be considered public records and shall be subject to the provisions of Florida Statute 119.07.

Is this a budgeted expenditure from the budget established at the last June Board of Trustees meeting? Yes.

What fund, cost center and line item(s) were used? CC0020, FD100, 64502 Inst. Memberships & Sponsorships.

Has Broward College used this vendor before for these products or services? Yes, historically membership dues was paid with purchase order.

Was the product or service acceptable in the past? Yes.

Was there a return on investment anticipated when entering this contract? This membership allows Broward College to be visible in the aviation community attracting new students to pursue aviation degrees at BC.

Was that return on investment not met, met, or exceeded and how? The University Aviation Association membership facilitates the promotion of Broward College and its programs to prospective students directly during various events as many employers attend these events which promotes relationships with BC.

Does this directly or indirectly feed one of the Social Enterprise tactics and how? Yes. Guarantee Access to Higher Education. Accelerate Entry into College. Membership provides visibility for potential students.
