



## EXECUTIVE SUMMARY

**Recommendation that the Broward College District Board of Trustees authorize a standard agreement (purchase order) with FL TRIO for a membership renewal and dues for FY2024-2025 for Developmental Education. Fiscal Impact: \$1,950.00.**

**Presenter(s):** Janice Stubbs, Vice President of Student Services

**What is the purpose of this contract and why is it needed?** FL (Florida) TRIO is part of a Tri-State nonprofit organization promoting opportunity, access, and success in Postsecondary Education for more than 50 years. TRIO Programs are Federally Funded by the Department of Education to provide outreach and student service programs to students who come from low-income, first generation and students with disabilities.

Membership to the Florida TRIO (FL TRIO) provide staff with access to educational seminars along with discounts for conference registration fees and workshop events. Additionally, FL TRIO members nominate eligible students for scholarship awards funded by FL TRIO.

**What procurement process or bid waiver was used and why?** Small purchase for Category One (\$0.00 - \$10,000) per College Procedure A6Hx2 -6.34 was used, where there are no formal or informal competitive requirements for goods and services acquired by the College at this dollar threshold. Membership dues, per the Florida

Statute 119. 01 (3) requires that all financial, business and membership records held by the organization in relation to the individual(s) or organization(s) for whom a purchase order is being issued are to be considered public records and shall be subject to the provisions of Florida Statute 119.07.

**Is this a budgeted expenditure from the budget established at the last June Board of Trustees meeting?**

No, this is a grant funded program by the Federal Department of Education and the budget assigned to this institutional membership was approved already by the Program Officer.

**What fund, cost center and line item(s) were used?** FD200, CC0093, CC0626, CC0287, GLC:64502. Institutional Memberships and Sponsorships.

**Has Broward College used this vendor before for these products or services?** Yes.

**Was the product or service acceptable in the past?** Yes.

**Was there a return on investment anticipated when entering this contract?** Yes.

**Was that return on investment not met, met, or exceeded and how?** The return on investment was met as it has provided staff with discounted rates to educational seminars and conference events. Networking and collaborating with members are essential to the success of the TRIO Grants objective. Information provided through these networking opportunities help to ensure that outcomes are being met and low income, first generation, and/or disabled students enrolled in the programs persist in school, graduate and/or transfer.
