Recommendation that the Broward College District Board of Trustees authorize the standard agreement (purchase order) with SIVCO, Inc. for the software renewal to service the laboratory inventory for the Science Department by utilizing bid waiver (Information technology). Fiscal Impact: Estimated \$2,100.00 (cumulative \$12,200.00).

What is the purpose of this contract and why is it needed? CHEMATIX© Chemical Management Software provides modules for inventory management and resource management. Access to remotely installed production system is provided by SIVCO, Inc. Laboratory inventory tracking has no limitation of the registered or concurrent users. Annual Software-as-a-Service usage fee includes hosting, upgrade, maintenance and support for North and South Campuses science laboratories during FY2024-2025. SIVCO, Inc. has provided excellent service to the College in the past and offers competitive pricing.

This software allows our chemical inventory to be accurate, organized and informative. Every in-house chemical is barcoded and inputted in the management system. This allows lab staff and faculty to manage and coordinate relevant federal and state protocols for the safe handling and storage of chemicals. Which in turn facilitates the safe handling and use of these chemicals by our students in their various science lab courses and is crucial to student learning outcomes and meeting specific course objectives.

What procurement process or bid waiver was used and why? The College used the bid waiver exemption provided for the information technology resources in accordance with FLDOE Rule 6A-14.0734(2)(g) and College Procedure 6AHx2-6.34 which cites the exception to the requirement to solicit competitive offers.

Is this a budgeted expenditure from the budget established at the last June Board of Trustees meeting? Yes.

What fund, cost center and line item(s) were used? FD101, CC0031,CC0218, GLC:65500:Software Subscriptions (Cloud, SaaS,PaaS,more).

Has Broward College used this vendor before for these products or services? Yes.

Was the product or service acceptable in the past? Yes, we have always had excellent quality products and good customer service.

Was there a return on investment anticipated when entering this contract? Yes, academic progression, standardization, and continuity, enabling all science students to have an equal learning experience on the cutting-edge equipment in the medical field.
