WILLIAM & MARY FY 2026 GRADUATE AND PROFESSIONAL PROGRAM TUITION

Consistent with tuition and fee authority granted to William & Mary in the Code of Virginia, the attached graduate and professional tuition are recommended for approval by the Board of Visitors.

The attached tuition schedules recommend no increase to tuition for general graduate students regardless of domicile status for FY26. Increases proposed to the Master of Accounting, MBA, MS in Business Analytics, executive MBA program, and a range of per credit hour rates brings the Mason School closer to competition within Virginia. The Law School has proposed tuition adjustments for the Juris Doctor (J.D.) and the Residential LLM programs of 2.5% for in-state rates and 3.3% for out-of-state rates to align with peer institutions. Online LLM (Per Credit Hour) rate were held flat and a 3% adjustment was proposed in the M.L.S. (Per Credit Hour) rate. These new proposed rates were established through market analysis and position W&M as competitive with peers while also reflecting the quality of W&M's education. Lastly, the School of Education has brought their Online MEd in Counseling up to a competitive market rate over a three year period. The increase from \$775 to \$825 per credit represents the final year of this process.

WHEREAS, the proposed increases to graduate and professional tuition result from analysis of the value of programs along with comparison to market competition; and

WHEREAS, setting tuition early in the admissions cycle is important to our graduate and professional schools in crafting financial aid packages and optimizing student yield.

THEREFORE, BE IT RESOLVED, That the William & Mary Board of Visitors approves the Graduate and Professional Tuition outlined in Tables 1-3 for FY26; and

THEREFORE, **BE IT ALSO RESOLVED**, that the Board will adopt comprehensive fees for students of all schools at its regularly scheduled meeting in April 2026.
