## **SECOND AND FINAL PUBLIC TAX HEARING 5:30 p.m., Tuesday, September 27, 2022**

The Special Meeting of the Board of Commissioners' Second and Final Public Tax Hearing of the North Broward Hospital District was held at the Broward Health Sports Medicine Building, 1601 S. Andrews Avenue, Suite 100, Fort Lauderdale, FL 33316.

## 6. FINAL MILLAGE RATE FOR THE NORTH BROWARD HOSPITAL DISTRICT, FISCAL YEAR 2023

6.1. Resolution FY23-03: A Resolution of the North Broward Hospital District Adopting the Final Levying of Ad Valorem Taxes for Broward County for Fiscal Year Beginning July 1, 2022 and Ending June 30, 2023; Providing for an Effective Date.

6.1.1. Tax Hearing Calendar, September 2022

6.1.2. Financial Impact of Various 2022/2023 Millage Rates

Mr. Alex Fernandez, SVP/Chief Financial Officer, requested the Board's consideration to approve the final millage rate for Fiscal Year 2023 and to approve Resolution FY23-03, as presented. Noted that the millage rate adopted for Fiscal Year 2022 was 1.2770 mills. The roll-back rate for FY 2023 was 1.1638 mills.

It was further noted that the proposed millage rate advertised in the TRIM notice and which the Board tentatively adopted for Fiscal Year 2023 was 1.6029 mills, which would result in a 37.73% percentage increase over the rolled-back rate.

Mr. Fernandez confirmed that Broward Health contributes to improving the health and well-being of the community through medical innovations, community education, mitigation of health disparities, and in many other ways. Despite the challenges of the Pandemic, the District is making meaningful progress. None of this would be possible without the continued support and advocacy received from community leaders and board members. He further noted that the District had not been spared from the financial impact affecting healthcare systems across the county. Unprecedented labor costs, supply chain delays, inflation, and the COVID-19 pandemic including testing, vaccinations, and the overall care of COVID positive patients continue to put financial pressure on our healthcare system. The ad valorem tax revenue increase will enable Broward Health to continue to advance the services for all of Broward County.

In accordance with the provisions of Chapter 200 of the Florida Statutes, the Board of Commissioners finally adopt the Fiscal Year 2023 millage rate for the North Broward Hospital

District at 1.6029 mills and pass Resolution FY23-03, as presented, which all Commissioners received for review prior to this meeting,

In sum, Chair Angier stated for the record that the North Broward Hospital District would approve Resolution FY23-03 and finally adopt a millage rate, as presented.

The rolled-back rate for fiscal year 2023 was 1.1638 mills. The proposed millage rate to be levied was 1.6029 mills. The percentage increase over the rolled-back rate was 37.73%.

**RESOLUTION FY23-03**

**A RESOLUTION OF THE NORTH BROWARD HOSPITAL DISTRICT ADOPTING THE FINAL LEVYING OF AD VALOREM TAXES FOR BROWARD COUNTY FOR FISCAL YEAR BEGINNING JULY 1, 2022 AND ENDING JUNE 30, 2023; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Board of Commissioners (the "Board") of North Broward Hospital District (the "District"), at a special board meeting held on July 20, 2022, adopted the District's calculated rolled-back rate of 1.1638 mills in accordance with § 200.065(1), Florida Statutes and approved the submission of a proposed millage rate of 1.6029 mills for fiscal year 2023, both as reflected on the Florida Department of Revenue's Certification of Taxable Value form provided to the Broward County Property Appraiser;

**WHEREAS**, the Board on September 15, 2022 held a public meeting as required by § 200.065, Florida Statutes, to consider the proposed millage rate and the tentative operating budget for the District's fiscal year 2023, and the Board tentatively adopted the District's budget and the proposed millage rate of 1.6029 mills; and

**WHEREAS**, the gross taxable value for operating purposes not exempt from taxation within the District's boundaries in Broward County has been certified to the North Broward Hospital District by the Broward County Property Appraiser as \$172,187,154,997.


**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the North Broward Hospital District, that:

1. The above-stated recitals are true and correct in every respect and are hereby incorporated herein by reference.
2. The rolled-back rate for FY2023 is 1.1638 mills which was calculated in accordance with § 200.065(1), Florida Statutes and submitted to the Broward County Property Appraiser on the Florida Department of Revenue's Certification of Taxable Value form.
3. The FY2023 final adopted millage rate shall be 1.6029 mills, which is a 37.73% increase over the rolled-back rate.
4. This resolution shall take effect immediately upon its adoption.


