10.1. CEO Update (Presenter - Shane Strum, President, Chief Executive Officer)

Mr. Strum presented his full monthly report, highlighting the five pillars (Quality, Service, People, Growth, and Finance) of the organization and the progress at each of the facilities.

In addition, the following videos were shared:

- Broward Health Imperial Point's 50th anniversary celebration held on October 25, 2022.
- Channel 6 News:
 - O Video featured Dr. Hector Rodriguez-Cortes highlighting a surge of kids hospitalized at the District with respiratory illnesses that were not related to COVID-19. Dr. Rodriguez-Cortes provided an overview of Respiratory Syncytial Virus (RSV), a common contagious virus that causes cold-like symptoms in the respiratory tract. Noted, it may cause bronchiolitis or inflammation of the lungs.
- Channel 4 New:
 - O Video featured two-time pediatric cancer survivor, Amanda Aiello, who was first diagnosed with acute myeloid leukemia, a type of blood cancer at 10-years old. Shortly after celebrating being cancer-free just three years after, she relapsed. Amanda received treatment at BHMC with Dr. Hector Rodriguez-Cortez, Pediatric Hematology-Oncologist. Patient is in remission, with the goal of running in a 5K.
