PROGRAM/PRODUCT LINE: Replacement of Radiographic Fluoroscopy (“R/F”) Unit

REQUEST: Broward Health Coral Springs is requesting funding in the amount of \$495,657 to purchase a new Shimadzu Radiographic Fluoroscopy unit to replace our current end-of-life Radiographic Fluoroscopy unit. The new unit will be a one-time purchase from Vizient vendor, CMS Imaging Inc. The new unit will include a 12-month system warranty to cover all parts and labor.


PURPOSE: Broward Health Coral Springs is proposing to replace the existing equipment in the Radiographic Fluoroscopy room to provide enhanced radiology services for a variety of GI procedures (Barium Swallow, Upper GI and Barium Enema exams).

SUBJECT: Broward Health Coral Springs is requesting funding in the amount of \$495,657 for the replacement of a 20-year-old, end-of-life Radiographic/Fluoroscopy (R/F) Unit.

BACKGROUND

Broward Health Coral Springs is requesting funding to replace the existing Radiographic/Fluoroscopy system to provide continued radiology services for a variety of GI procedures (Barium Swallow, Upper GI and Barium Enema exams). The current equipment is past end of life. Replacing the current R/F system will allow Broward Health Coral Springs to continue serving the needs of the community, while at the same time improving the capability of the radiology service line.

With the replacement of our current system, patients treated at Broward Health Coral Springs will be able to receive more expedited care with a lower dose of radiation. This is currently hindered due to the antiquated equipment. A new R/F solution will allow us to better meet the needs of the community. The new system will also enable BHCS to be compliant with regulatory requirements pertaining to radiation dose monitoring.

In summary, we recommend the funding of the replacement of the Radiographic/Fluoroscopy room at BHCS to continue our efforts to enhance the services we provide to the patients we serve

ACTION/PROJECT DESCRIPTION

Replacement of the Radiographic Fluoroscopy Unit to allow BHCS to continue meeting the needs of the community.

FINANCIAL/BUDGETARY IMPACT AND GROWTH POTENTIAL

BHCS performs approximately 100 exams per month. Loss of this service due to failing equipment that is past end of life will have a negative impact to Broward Health Coral Springs.

JUSTIFICATION

A new system will help Broward Health Coral Springs remain competitive, drive continued development of our service lines and clinical programs, and allow us to better serve patients in our community.

STAFF RECOMMENDATION

Therefore, it is requested that the Board of Commissioners of the North Broward Hospital District authorize the District to approve the funding in the amount of \$495,657 for the purchase of a new Shimadzu Radiographic Fluoroscopy unit at Broward Health Coral Springs.
